AN ORDINANCE making a supplemental appropriation of \$513,420 to the Prosecuting Attorney for legal expenses applicable to cable television refranchising and \$50,000 to the Council Administrator for the development and distribution of a public notification mailer regarding cable television in King County; and amending Ordinance 11578, Sections 7, 25 and 29, as amended.
