STATEMENT OF FACT:


- 1. Intention of the proposed annexation of territory known as Annexation 94-1 to the Sammamish Plateau Water and Sewer District was filed with the county council effective May 9, 1995.
- 2. Sammamish Plateau Water and Sewer District has found the petition for annexation to be sufficient and has, by Resolution No. 1785, concurred with the proposed annexation.
- 3. Sammamish Plateau Water and Sewer District filed a Determination of Nonsignificance dated July 7, 1994, on the proposed annexation.
- 4. The county council held a public hearing on the day of $\frac{5}{1000}$, 19 $\frac{95}{1000}$ and has considered the criteria set forth in R.C.W. 56.03.060 and R.C.W. 57.02.040.

SECTION 1. The annexation of territory known as Annexation 94-1 by the Sammamish Plateau Water and Sewer District, and described in Attachment A, is approved. This proposed annexation is consistent with R.C.W. 56.03.060 and R.C.W. 57.02.040.

SECTION 2. The Sammamish Plateau Water and Sewer District is the appropriate entity to provide water and sewer service to the area proposed to be annexed.

SAMMAMISH PLATEAU WATER AND SEWER DISTRICT ANNEXATION 94-1 (aka ISSAQUAH SCHOOL SITE E-11)

LEGAL DESCRIPTION

19 Acres, more or less, including - That portion of the north half of the northwest quarter of Section 13, T 24 N, R 6 E, Willamette Meridian, in King County, Washington, described as follows:

Beginning at the southwest corner of the northeast quarter of the northwest quarter of said Section 13; thence South 88°22'11" East along the south line thereof 10.00 feet; thence North 01°37'49" East 49.25 feet; thence North 43°24'13" East 592.10 feet; thence North 32°11'28" West 594.95 feet; thence North 01°24'15" East 50.00 feet to the southerly margin of Issaquah-Fall City Road; thence continuing North 01°24'15" 30 feet to the centerline of SE Issaquah-Fall City Road; thence following the centerline of Issaquah-Fall City Road westerly along said centerline to the centerline of the intersection of S.E.
