AN ORDINANCE relating to salary schedules for the department of metropolitan services and other salary and hiring matters and amending Ordinance 11032, Section 13 (part) and K.C.C. 28.08.020 and adding new section.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. Findings. One of the critical steps in implementing the consolidation of King County and the former Municipality of Metropolitan Seattle (now the department of metropolitan services) is to develop a single classification and compensation system for the employees of the consolidated government. When the voters were asked to approve the consolidation, they were told that it would not result in increased costs. Therefore, the proposed interim salary structure pending before the council, which would elevate the salary structure for all of the county's senior managers, should not be adopted. The council finds that it would be more appropriate to retain the county's existing 10-step salary plan as the salary plan for senior management positions and apply that plan to senior management positions in the department of metropolitan services.

SECTION 2. Ordinance 11032, Section 13 (part) and K.C.C. 28.08.020 and is hereby amended as follows:

Salary schedule. The human resources division will maintain the adopted salary schedule for the department, including all classifications and their corresponding salary ranges. The salary schedules issued under the authority of

the executive director of Metro or pursuant to collective 1 bargaining and attached as Exhibit A to Ordinance No. .2 3 11032((-)) are hereby adopted, as amended by the salary schedule attached as Exhibit A to this ordinance. The 4 ((Said)) salary schedule contained in Exhibit A to Ordinance 5 6 11032 will be adjusted to reflect cost of living adjustments adopted by the Metro Council in 1993 and additional job 7 classifications and salaries as may be determined by the 8 executive director or by collective bargaining on or before 9 December 31, 1993. The salary schedule in effect on December 10 31, 1993, including the revisions adopted by said Metro 11 Council and the executive director and the revisions contained 12 13 in Exhibit A to this ordinance, shall constitute the salary schedule for the department((-)) and shall be adjusted to 14 reflect cost of living adjustments adopted by the Metropolitan 15 16 King County Council.

NEW SECTION. SECTION 3. Any department of metropolitan services employee whose current salary exceeds the maximum salary of the new pay range assigned pursuant to Exhibit A to this ordinance shall not be eligible for merit increases or
