ORDINANCE NO. **11830**

AN ORDINANCE granting the extension of cable television franchises to All Points Associates, Inc., Edmonds Cable Company and Summit Communications, Inc.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. Findings of Fact: A. All Points Associates,

Inc., currently holds two cable television franchises granted by King County. Those franchises will expire on March 1, 1995.

B. Summit Communications, Inc. currently holds a cable television franchise granted by King County. That franchise will expire on March 1, 1995.

C. Edmonds Cable Company currently holds a cable television franchise granted by King County. That franchise will expire on March 1, 1995.

D. The county wishes to extend the franchises held by All Points Associates, Inc., and Summit Communications, Inc., to facilitate an orderly review of franchise renewals.

E. All of the franchise area covered by the Edmonds Cable Company's franchise lies within the newly incorporated city of Shoreline. Shoreline's city council has not yet been elected, however, and jurisdiction over the rights-of-way located within the city's boundaries remains with the county at this time.

F. Each of these companies has agreed that its franchises be extended.

G. The council has determined that it is in the best interest of the citizens of King County to grant the franchise extensions listed below.

SECTION 2. The council hereby grants All Points Associates, Inc. an extension of franchise numbers 5598 and 5870 until December 31, 1995.

1 SECTION 3. The council hereby grants Summit
 2 Communications, Inc., an extension of franchise number 5602
 3 until December 31, 1995.

4 SECTION 4. The council hereby grants Edmonds Cable Company
 5 an extension of franchise number 563 until June 30, 1996.

6 SECTION 5. These extensions are granted subject to the
 7 condition that if within thirty (30) days of the council's
 8 passage of this ordinance a franchisee fails to sign a
 9 franchise extension agreement in substantially the form
 10 contained in Exhibit A, which agreements are attached to and a
 11 part of this ordinance, the franchise extension for that
 12 company shall be deemed to be denied and any extension granted
 13 to that company by this ordinance shall be null and void.
