## STATEMENT OF FACTS

- 1. Seattle City Light's electrical franchise numbers 595 and 7225 to operate and maintain an electrical system on county road right of way have expired.
- 2. King County Council Motion 9261 extended City Light franchise 595 and 7225 through June 30, 1995 to allow county departments to review standard franchise terms and conditions in light of changes in technology since the original franchises were adopted.
- 3. Seattle City Light has requested additional time to review the terms and conditions of the new proposed franchise.
- 4. The extension of electrical franchise numbers 595 and 7225 have been referred to relevant county departments for review.
- 5. No objections have been raised to the granting of this extension.
