AN ORDINANCE establishing the date for an election on the question of annexation of the city of Burien to King County Fire Protection District No. 2 and declaring an emergency.

#### FINDINGS OF FACT:

The Burien city council, consistent with RCW 52.04.061, has initiated annexation into King County Fire Protection District No. 2 by adoption of Ordinance No. 153 stating an intent to join the fire protection district and finding the public interest will be served thereby.

The commissioners of King County Fire Protection District No. 2. by Resolution No. 95-02 have concurred with the proposal of the council of the city of Burien and their intent to join the fire district by annexation in accordance with RCW 52.04.061.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. A special election shall be held on the 7th day of November, 1995, within the city of Burien and in King County Fire Protection District No. 2. The ballot proposition shall be in substantially the following form in accordance with RCW 57.04.071.

"Shall the City of Burien, Washington be annexed to and be part of King County Fire Protection District No. 2?

SECTION 2. Notice of election shall be published as required by law.

ORDINANCE NO. 153

AN ORDINANCE OF THE CITY OF BURIEN, WASHINGTON, CALLING FOR A SPECIAL ELECTION TO BE HELD ON NOVEMBER 7, 1995, CONCERNING ANNEXATION OF THE CITY TO KING COUNTY FIRE PROTECTION DISTRICT NO. 2

WHEREAS, the City Council has expressed its intent to annex into King County Fire Protection District No. 2 ("District No. 2"), and the Board of Commissioners of District No. 2 have concurred with the proposed annexation; and

WHEREAS, RCW 52.04.071 specifies the manner for a special election on the question of annexation by a city to a fire district; and

WHEREAS, the City Council finds it to be in the public interest to place the question of annexation before the voters;

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF BURIEN, WASHINGTON, DO ORDAIN AS FOLLOWS:

Section 1. Call for Special Election. The City Council authorizes submittal of a ballot measure to the voters of the City of Burien, and to the voters of King County Fire Protection District No. 2, on the question whether the City should annex to District No. 2.

Section 2. Duties of the City Clerk. The City Clerk is requested to deliver certified copies of this ordinance to the Clerk of the Metropolitan King County Council, the King County Auditor, the King County Treasurer, and the Manager of the King County Records and Elections Division, requesting that a special election be held on the November 7, 1995, General Election ballot to determine whether the City shall be annexed to King County Fire Protection District No. 2.

Section 3. Severability. Should any section, paragraph, sentence, clause or phrase of this ordinance, or its application to any person or circumstance, be declared unconstitutional or otherwise invalid for any reason, or should any portion of this ordinance be preempted by state or federal law or regulation, such decision or preemption shall not affect the validity of the remaining portions of this ordinance or its application to other persons or circumstances.

Section 4. Effective Date. This ordinance shall be published in the official newspaper of the City, and shall take effect and be in full force five (5) days after the date of publication.
