ORDINANCE NO. 12110

AN ORDINANCE extending water system franchise number 290 for the Maplewood Addition Water Cooperative until December 1, 1996, authorizing the issuance of right-of-way construction permits in Council District No. 6.

STATEMENT OF FACTS:

- 1. The Maplewood Addition Water Cooperative franchise No. 290, to operate and maintain a water system on county road right-of-way, has expired.
- 2. The Cooperative filed an application for a water franchise in Council District No. 6 on November 3, 1995 to construct, operate, and maintain their existing water system to serve primarily a single family residential area in accordance with R.C.W. 36.55.010.
- 3. King County Code Chapter 6.27 requires that the utility franchise application be approved by the Utilities Technical Review Committee (UTRC) and be consistent with the county comprehensive plan and regulations of the Seattle-King County Health Department and the Washington State Department of Health.
- 4. The Cooperative is in the process of preparing and obtaining approval of its water comprehensive plan to bring it in compliance with King County Code Chapter 13.24 Sewer and Water Comprehensive Plans. The Cooperative anticipates that this process could take a year to complete.
- 5. In order to provide the Cooperative with the time needed to complete its water plan and to allow the Cooperative to continue to obtain the necessary right-of-way construction permits to maintain and operate the existing water system on county road right-of-way, the Cooperative has requested that franchise No. 290 be extended.
- 6. The extension of Water franchise No. 290 has been referred to the relevant county departments for review.
- 7. The county executive has recommended approval of the water franchise extension.

BE IT ORDAINED BY THE COUNCIL OF KING SECTION 1. Notwithstanding any provision of K.C. 13.24 2 to the contrary, the King County executive is hereby 3 authorized to grant an extension of Water franchise No. 290 4 for the Maplewood Addition Water Cooperative until December 5 6 1, 1996, in substantially the same form as Attachment "A".
