1215 ORDINANCE NO.

AN ORDINANCE extending water system franchise No. 319 for Water District 45 until July 31, 1997, and authorizing the issuance of right-of-way construction permits in Council Districts No. 5 and 8.

STATEMENT OF FACTS

- Water District 45's Franchise No. 319, to operate and maintain a water system on County road right-of-way, has expired.
- The District filed an application for a water franchise 2. in Council Districts No. 5 and 8 on October 5, 1995 to construct, operate, and maintain their existing water system to serve single family residential and multi-family areas, with pockets of commercial areas.
- King County Code Chapter 6.27 requires that the utility franchise application be approved by the Utilities Technical Review Committee (UTRC) and be consistent with the County's comprehensive plan, Seattle-King County health department and the State department of health regulations.
- The District is in the process of preparing and obtaining approval of its water comprehensive plan to bring it in compliance with the state and county regulations. The District anticipates that this process will take a year to complete.
- In order to provide the District with the time needed to complete its water plan and to allow the District to continue to operate and maintain the existing water system on county roads right-of-way, the District has requested that Franchise No. 319 be extended.
- The extension for Water Franchise No. 319 has been referred to the relevant County departments for review.
- The County executive has recommended approval of the water franchise extension.
