SUBSTITUTE ORDINANCE NO.

12209

2 AN ORDINANCE adopting a special
3 assessment roll to fund the approved
4 activities of Lake Management District
5 No. 1 in the Beaver Lake watershed,
6 authorizing King County department of
7 natural resources, surface water
8 management division, expenditure
9 authority for Lake Management District
10 No. 1 funds, establishing interest and
11 penalties for non-payment, and
12 authorizing the Executive to solicit
13 advisory board nominees to oversee the
14 expenditure of such funds.

15 STATEMENT OF FACTS:

- 16 1. Ordinance 11956 created Lake Management District No.
17 1 in the Beaver Lake watershed, pursuant to the
18 favorable vote of property owners in the district, and
19 delegated responsibility to the King County Board of
20 Appeals for hearing objections to a proposed special
21 assessment roll to fund the approved activities of the
22 district.
- 23 2. The Board of Appeals held a hearing on the appeals on
24 December 8, 1995. The board recommends approval of the
25 special assessment roll shown as Attachment A, which
26 makes adjustments for appeals eliminating separate
27 assessments for contiguous parcels, exempting qualified
28 low-income senior taxpayers from the special assessment,
29 and removing property found to be outside the watershed
30 from the special assessment roll.
- 31 3. Pursuant to R.C.W. 36.61, the Metropolitan King
32 County Council must approve a final special assessment
33 roll to fund the approved activities of the district.
- 34 4. The Metropolitan King County Council must authorize
35 the transfer of Lake Management District No. 1 funds
36 into surface water management division operation funds
37 in order to reimburse the division for implementation of
38 Lake Management District No. 1 activities.
- 39 5. Pursuant to R.C.W. 36.61, the Metropolitan King
40 County Council must establish an amount of interest that
41 will be imposed on late special assessments and specify
42 the penalty that will be associated with delinquent
43 assessments.

1 6. Pursuant to Ordinance 11956 and the ballot proposal
2 on the district approved by property owners, a non-paid
3 advisory board shall be established to assist King
4 County in the development and implementation of the work
5 program funded by Lake Management District No. 1
6 revenues.

7 BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

8 SECTION 1. Special Assessment Roll. The special
9 assessment roll shown as Attachment A, which shall fund the
10 approved activities (Attachment B) of Lake Management
11 District No. 1 in the Beaver Lake watershed (Attachment C),
12 is hereby approved for calendar year 1996. The special
13 assessment roll shall be adjusted annually through calendar
14 year 2000, consistent with Ordinance 11956. Adjustments may
15 be made for increases to the number of non-contiguous parcels
16 in the district, resulting from subdivisions; or reductions
17 to the number of non-contiguous parcels because of removal
18 from the assessment roll of taxpayers of record qualifying
19 for low-income status as defined in R.C.W. 84.36.381, or
20 removal of parcels which are located outside of the Beaver
21 Lake Watershed.

22 For a parcel which is subdivided after the special
23 assessment role is adjusted but prior to the payment of the
24 annual assessment, the assessment shall be equally divided
25 among the new parcels for that year and paid to the county
26 treasurer as a portion of the original parcel assessment.
27 For subsequent years, the subdivided parcels shall be counted
28 among the total number of parcels in the affected zone, and
29 the individual parcel assessment shall be recalculated during
30 the annual adjustment of the special assessment role.

31 SECTION 2. Authority. The program and responsibilities
32 herein created in association with the formation of Lake

1 Management District No. 1 shall be administered by the King
2 County department of natural resources, surface water
3 management division.

4 SECTION 3. Delinquencies and Foreclosures.

5 A. As set forth in R.C.W. 36.61.200, a twenty day
6 period shall be allowed after the due date of the Lake
7 Management District No. 1 special assessment during which no
8 interest, penalty, or collection costs shall be imposed.
9 After this twenty day period, interest shall be assessed at
10 the interest rate established in K.C.C. 9.08.100A and
11 computed on a monthly basis until paid. Interest shall be
12 calculated at the rate in effect at the time of payment of
13 the charges regardless of when the charges were first
14 delinquent.

15 B. Pursuant to R.C.W. 36.61.230, the county shall have a
16 lien for delinquent Lake Management District No. 1 special
17 assessments, including interest thereon, against any property
18 subject to the special assessment. The lien shall be
19 paramount and superior to any other lien or encumbrance
20 except a lien for general taxes. Pursuant to R.C.W.
21 36.61.240, such lien shall be effective and shall be enforced
22 and foreclosed in the same manner as special assessments are
23 foreclosed in R.C.W. 36.94. As stipulated in R.C.W. 36.94,
24 collections shall include costs of foreclosure in addition to
25 the special assessment and interest.

26 SECTION 4. Advisory Board Composition, Appointment, and
27 Responsibilities.

28 A. The Lake Management District No. 1 advisory board
29 shall be comprised of six members, four of whom shall be
30 selected from zone 1 properties, fronting on the lake, and

1 two of whom shall be selected from zone 2 properties from the
2 remainder of the watershed.

3 B. Members of the advisory board shall serve for three
4 year appointments. Individuals appointed for the second term
5 of the advisory board will fulfill their appointment at the
6 conclusion of the fifth year of activities of Lake Management
7 District No. 1. The solicitation of nominees to serve on the
8 advisory committee for oversight of Lake Management District
9 No. 1 funds shall be conducted by the King County department
10 of natural resources, surface water management division. The
11 Executive shall make all final appointments to the advisory
12 board in consultation with the Metropolitan King County
13 Council or its appointed designee, subject to Council
14 approval.

15 C. The responsibilities of the advisory board shall
16 include: (1) assisting the surface water management division
17 each April in the development of the annual Lake Management
18 District No. 1 work program, goals, milestones, and budgets;
19 (2) providing oversight of and consultation to the surface
20 water management division in the implementation of Lake
21 Management District No. 1 work program elements; and (3)
22 submitting an annual progress report to the Metropolitan King
23 County Council, Executive, and Beaver Lake Community Club
24 each January summarizing the activities and accomplishments
25 of Lake Management District No. 1 implementation.


1 SECTION 5. The clerk of the council is directed to



Attachment B:Proposed Activities to be Funded by LMD

The Beaver Lake Management District is proposed to be funded at \$175,000 over a five-year period. The primary activities to be funded with this assessment would include: 1) construction site inspection and monitoring; 2) lake, stream, and wetland monitoring; 3) stormwater facility monitoring and inspection; and 4) community education.

The development and implementation of the work program for these activities would be overseen by the LMD Advisory Board as established by the King County Council or its appointed designee. The general scope of work for each activity includes the following:

Construction site inspection and monitoring. Increased County inspection and monitoring of new construction sites in the watershed would be performed on a routine basis. Inspection activities would emphasize the proper installation and use of onsite erosion control materials, the maintenance of native growth easements and buffers during construction, and the enforcement of corrective actions as appropriate. Inspection frequency would be increased during the wet season to minimize the off-site transport of sediment and nutrients.

Lake, stream, and wetland monitoring. Routine water quality monitoring would be performed at all lake inflows and at the established in-lake sites located in Beaver Lake 1 and 2. The program would be designed to enhance the current volunteer monitoring activities which are focused only on Beaver Lake 2, expand those activities to Beaver Lake 1, and increase the frequency and the monitoring scope for both Beaver Lake 1 and 2. Trained volunteers would be used to perform monthly in-lake monitoring activities. Inflow monitoring would be performed on a monthly basis during April-September and twice monthly during the remaining months of the year by volunteers. The five-year monitoring program would be approved by the LMD Advisory Board and subject to annual adjustments by the board if needed.

Stormwater facility monitoring and inspection. Proper functioning of stormwater facilities has been identified as being essential to the protection of Beaver Lake water quality. To ensure that new stormwater treatment facilities are functioning properly, LMD funds would be used to support an increase in monitoring and facility inspection frequency for their effectiveness in removing phosphorus. These monitoring activities would be complementary to existing monitoring and inspection conditions in place for new developments and are not intended to be duplicative.


Community education. A community education program would be developed by the LMD Advisory Board with the assistance of the County to address homeowner and watershed resident activities which contribute to the water pollution of the lake. Activities to be considered include onsite septic system maintenance, lawn and garden maintenance, shoreline restoration, aquatic plant management, and waste disposal.

Additional items to be funded through LMD revenues include annual collection costs (\$4 per parcel) and a portion (25%) of standard indirect costs (charged on staff salaries and benefits) associated with implementation of the management plan. Examples of indirect costs include computer operation and maintenance, office supplies, telephone charges, building and equipment rental costs, and electric costs.

All new or expanded activities which address the goals of lake water quality protection of Beaver Lake would be subject to the oversight and approval of the LMD Advisory Board. If grant matching funds are procured, the existing LMD activities described above would be enhanced and expanded to include groundwater monitoring, Geographic Information System (GIS) watershed updating, lake water quality modeling, and revision of the management plan.
