ORDINANCE NO. 1222

AN ORDINANCE authorizing the conveyance of certain open space properties to the city of Newcastle, located in council district 6.

STATEMENT OF FACTS:

King County owns certain open space properties within the incorporated area of Newcastle, all located in council district 6.

The county desires to divest itself of ownership, management and financial responsibility for open space properties now within city boundaries.

The city has agreed to own, operate and maintain the open space properties within its boundaries.

The conveyance of the open space properties is consistent with the desire of the county for conveyance of neighborhood and local facilities to local jurisdictions.

In consideration of the mutual benefits to be derived, it would be in the best interests of the citizens of King County to convey the lands described herein to the city.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

The King County executive is hereby SECTION 1. authorized to execute the necessary documents to convey to the city of Newcastle, for mutual benefits, the county open space properties, described as follows:
