AN ORDINANCE extending water system franchise 1032 for the Maury Mutual Water Company until November 11, 1997, and authorizing the issuance of right-of-way construction permits in Council District 8.

### STATEMENT OF FACTS

- Maury Mutual Water Company's Franchise 1032, to operate and maintain a water system on County road right-of-way, will expire on November 11, 1996.
- The Company will file an application for a water franchise in Council District 8 to construct, operate and maintain their existing water system to serve primarily a single family residential area with pockets of commercial areas when its comprehensive plan is approved by King County.
- The Company is in the process of preparing and obtaining approval of its water comprehensive plan to bring it in compliance with the state and county regulations. The Company anticipates that this process will take a year and a half to complete.
- In order to provide the Company with the time needed to complete its water plan and to allow the Company to continue to operate and maintain the existing water system on county road rights-of-way, the Company has requested that Franchise 1032 be extended.
- The extension for Water Franchise 1032 has been referred to the relevant County departments for review.
- The County executive has recommended approval of the water franchise extension.

WHEREAS, the referenced Maury Mutual Water Company franchise will expire on November 11, 1996; and

WHEREAS, Maury Mutual Water Company will request a renewal of said franchise when its comprehensive plan has been approved; and

WHEREAS, the Maury Mutual Water Company and the King County Utilities Technical Review Committee recommend that said franchise be extended until November 11, 1997 to give the Company the opportunity to complete and obtain approval of its water comprehensive plan and franchise; and

WHEREAS, no objections have been raised to the granting of the request; and

WHEREAS, King County has approved the extension of this franchise until November 11, 1997 through the passage of Ordinance No. 12252 subject to the conditions contained in the ordinance and agreement.

NOW, THEREFORE, King County, Washington and the Maury Mutual Water Company agree as follows:

- 1. The terms of King County Water Franchise 1032 are hereby approved and extended so that they will now expire on November 11, 1997.
- 2. All other conditions of King County Water Franchise 1032 shall remain in full force and effect and are not modified or amended by this agreement or Ordinance No. /2252.
