ORDINANCE NO. **12297**

AN ORDINANCE making appropriations of \$787,152 to various Capital Improvement projects, disappropriating \$787,152 from various Capital Improvement Projects, and amending Ordinance 12029, Section 110, and Attachment 2, as amended.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. There is hereby approved and adopted a supplemental appropriation of \$551,152 to the King County Marymoor Addition Project from a disappropriation of \$531,152 from Klahanie to Redmond Watershed Trail Project and \$20,000 from the King County Trail Contingency Project; approving and adopting appropriations to two new projects in Fund 3152, from a disappropriation from the East Lake Sammamish Project (\$120,000 to Project 373102 -Marymoor Park Addition; and \$116,000 to CIP Project 373101 - Idylwood Park.

SECTION 2. Ordinance 12029, Section 110, as amended, is hereby amended by adding thereto and inserting therein the following:
