ORDINANCE NO. **12312**

AN ORDINANCE authorizing expansion of the project scope of the King County Hollywood Hill Trail 1989 Open Space Bond project to include construction of a bridge at 155th Street Northeast, acquisition, design and paving of a trail parallel to 145th Street Northeast, and design and construction of a bridge across the Sammamish River parallel to 145th Street Northeast.

PREAMBLE:

1. King County has attempted to purchase property interests identified in the Hollywood Hill Trail 1989 Open Space Bond project, but is unable to acquire a route acceptable to the local community.
2. The design and construction of a bridge across 155th Street Northeast along the Tolt Pipeline Trail will accomplish the safe road crossing intended in the original project scope, and in addition, public safety improvements including the acquisition, design and construction of a pedestrian and bicycle trail adjacent to 145th Street Northeast and design and construction of a pedestrian and bicycle bridge crossing over the Sammamish River adjacent to 145th Street Northeast, have also been identified and are needed immediately for connections to the Tolt Pipeline Trail and Sammamish River Trail.
3. The King County Open Space Citizens Oversight Committee recommends that the scope of the King County Hollywood Hill Trail 1989 Open Space Bond Project should be expanded to include the 155th Street Northeast bridge design and construction, and the proposed improvements noted above.
4. The City of Woodinville has obtained additional funding to contribute towards the improvements proposed in this project scope change.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:


SECTION 1. There is hereby approved and adopted an expansion of the project scope of the King County Hollywood Hill Trail 1989 Open Space Bond project to include construction of a bridge at 155th Street Northeast, acquisition, design and paving of a trail parallel to 145th



**Description of Expanded Scope of Hollywood Hill Trail
1989 Open Space Bond Project**

- 1. Bridge at 155th NE:** Design and construction of a bridge across 155th Street NE along the Tolt Pipeline Trail will provide a safe crossing for pedestrians, equestrians and bicyclists. The bridge crossing adjacent to the Tolt water pipeline will be designed subject to the Seattle Water Department's review and approval of engineering plans.

- 2. Bridge at 145th Street NE:** The design and construction of a bridge at 145th Street NE will provide safe access for pedestrians, equestrians, and bicyclists from the existing Sammamish River Trail to the wineries, brewery, and other Woodinville attractions across the Sammamish River.

- 3. Trail along 145th Street NE:** The acquisition, design and paving of a 600 foot long trail parallel to the north side of 145th Street NE will provide safe access for pedestrians, equestrians and bicyclists to the Sammamish River Trail from nearby Woodinville attractions.
