AN ORDINANCE appropriating \$38,500 to Internal Support and \$447,216 to Transit to provide a comprehensive transportation program for all King County employees; and amending Ordinance 12029, Sections 38 and 108, as amended.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. There is hereby approved and adopted a supplemental appropriation of

\$38,500 to Internal Support from the unencumbered Current Expense Fund Balance and

\$447,216 to Transit supported by a federal grant of \$350,000, additional revenues from other

funds of \$41,000, and \$56,216 from the unencumbered Public Transportation Fund balance, to

provide a comprehensive transportation program for all King County employees.

SECTION 2. Ordinance 12029, Section 38, as amended, is hereby amended by adding

SECTION 3. Ordinance 12029, Section 108, as amended, is hereby amended by adding thereto and inserting therein the following:

TRANSIT - From the Public Transportation Fund, there is hereby appropriated to:

Transit \$447,216

The maximum number of additional FTEs for Transit shall be: 0.50

PROVIDED THAT:

No funds appropriated for the 1996 budget year may be expended to provide any employee with a bus pass at no charge to the employee, unless the employee received such a pass before the effective date of this ordinance; provided, however, that this limitation shall not affect any employee who under a collective bargaining agreement is entitled to a bus pass free of charge.
