AN ORDINANCE related to road redesignation; changing the name of 318th Way Northeast, Northeast 176th Street, 318th Avenue Northeast, Northeast 180th Place, Northeast 185th Place, Northeast 190th Street, 305th Avenue Northeast, and Northeast 203rd Street to "Mountain View Road Northeast".

## PREAMBLE:

This is a continuous stretch of roadway, approximately four miles in length, commonly known as "Mountain View Road" with eight different official designations. Application has been received from forty-four property owners, constituting ninety percent of those property owners whose addresses would be affected, requesting renaming of the entire roadway to "Mountain View Road Northeast.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. The approximately four mile continuous stretch of roadway, commonly known as "Mountain View Road," designated as 318th Way Northeast, Northeast 176th Street, 318th Avenue Northeast, Northeast 180th Place, Northeast 185th Place, Northeast 190th Street, 305th Avenue Northeast, and Northeast 203rd Street, described as commencing in a northwesterly direction from the intersection of Northeast Cherry Valley Road and Kelly Road Northeast in Section 9, Township 26 North, Range 7 East, E.W.M. and continuing through Sections 4 and 5, Township 26 North, Range 7 East, E.W.M. and ending at the King County line in the northwest corner of Government 3 in Section 5, Township 26 North, Range 7 East, E.W.M., and described on Attachment A to this ordinance and shown on Attachment B to this ordinance, is hereby redesignated in its entirety as "Mountain View Road Northeast".

**SECTION 2.** The 20-day notice requirement for affected property owners in Ordinance 10915, Section 2 shall be met.

SECTION 3. The director of the department of public works shall accomplish any necessary sign changes within sixty days of the effective date of this ordinance. **SECTION 4.** The director of the department of development and environmental services shall accomplish any necessary address change notifications within ninety days of the effective date of this ordinance.
