AN ORDINANCE establishing the date for an election to determine whether an area known as Covington shall be incorporated as a non-charter code city and declaring an emergency.

PREAMBLE:

Pursuant to the provisions of Chapter 35A.03 of the Revised Code of Washington, a petition for incorporation as a noncharter code city, signed by qualified voters resident within the limits of the proposed city equal in number to ten percent of the voters cast in the proposed area at the last preceding general state election has been presented to the Records and Elections Division.

The petition for incorporation states that the form of government under which the proposed city will operate in the event it is incorporated shall be Council Manager, sets forth the proposed boundaries of the proposed incorporation, states that the name shall be the City of Covington and that the number of inhabitants therein as nearly as may be estimated, is 12,500 and prays that it may be incorporated.

The superintendent of elections has determined that the petition for incorporation does not violate the prohibitions contained in RCW 35.02.010 with regard to number of inhabitants and that there are a sufficient number of valid signatures on the petition.

Pursuant to the provisions of RCW 36.93.100 the Boundary Review Board (BRB) invoked jurisdiction and in accordance with RCW 36.93.160 on August 29, 1996, filed its written decision approving with modifications the proposed incorporation. No appeal has been filed.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. The King County Boundary Review Board has deemed the matter of an election for incorporation of the City of Covington approved as of August 29, 1996.

SECTION 2. The name of the proposed city shall be the City of Covington.

SECTION 3. The official population of the proposed City of Covington, if incorporated, shall be approximately 12,500.

SECTION 4. An election shall be held on the 5th day of November 1996, within the area of the proposed City of Covington, as hereinafter described, for the purpose of submitting to the qualified electors the determination of whether it shall be incorporated as a non-charter code city, under the Council Manager plan of government proposed in the petition.

SECTION 5. The ballot title for the incorporation shall be drafted by the prosecuting attorney.

SECTION 6. The boundaries of the territory proposed for incorporation are described in exhibit A attached hereto.

SECTION 7. The election shall be conducted pursuant to Title 29 and RCW Chapter 35.02.

SECTION 8. Notice of the election shall be published as required by law.


