ORDINANCE NO. <u>125</u>7]

AN ORDINANCE authorizing the conveyance of certain parks, recreation and open space property to the City of Shoreline and authorizing the Executive to enter into agreements with the City of Shoreline relating to parks and recreation properties and services.

PREAMBLE

- 1. The City of Shoreline (the City) desires to own, operate, and maintain parks, open space, recreation facilities and programs and other municipal programs, facilities and properties inside its boundaries.
- 2. King County desires to divest itself of ownership, management, and financial responsibility for non-regional parks, open space, recreational facilities and programs inside the City boundaries as directed by Motion 8056 and the King county Park, Recreation and Open Space Plan adopted by Ordinance 12349.
- 3. The King County executive has determined that, because of the agreement of the City to operate and maintain the properties in perpetuity as public park, recreation facility and open space, the properties and property improvements are surplus to the foreseeable needs of the county and should be conveyed to the City subject to the terms and conditions of the interlocal agreement authorized herein.
- 4. In consideration of the mutual benefits to be derived, it would be in the best interests of the citizens of King County to convey the real property and property improvements described herein to the City.
- 5. The City also desires to provide quality parks maintenance and recreation services for residents of the City, and the County is willing and able to provide such parks maintenance and recreation services to the City.
- 6. It is in the public interest that jurisdictions cooperate to provide effective and cost efficient service, and pursuant to RCW 39.34 the City and the County are authorized to enter into agreements for cooperative actions.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. The King County executive, on behalf of the citizens of King County, is hereby authorized to execute deeds of conveyance in favor of the City of Shoreline for the real property listed on the attached agreement and to execute, substantially in the forms attached, two interlocal agreements and one joint cooperative agreement with the City of Shoreline relating to the ownership, funding, operation and
