ORDINANCE NO. 12619

AN ORDINANCE extending electrical franchise numbers 595 and 7225 for Seattle City Light through June 30, 1997, authorizing the issuance of right of way construction permits in Council Districts 1, 5 and 8.

STATEMENT OF FACTS:

- 1. Seattle City Light's electrical franchise numbers 595 and 7225 to operate and maintain an electrical system on county roads in council districts 1, 5 and 8 will expire on October 31, 1996.
- 2. The City of Seattle has requested renewal of said franchises.
- 3. King County Ordinance 12388 extended franchise numbers 595 and 7225 through October 31, 1996 so that King County and the City of Seattle could resolve their disagreements over the terms and conditions of the new franchise.
- 4. All but two of the franchise issues have been resolved. Extension of the franchises is necessary for the uninterrupted issuance of permits to serve City Light customers in unincorporated King County.
- 5. The extension of the franchises through June 30, 1997 will allow sufficient time to conclude negotiations and obtain both city council and county council approval of the new franchise.
- 6. The extensions of electrical franchise numbers 595 and 7225 have been referred to relevant county departments for review.
- 7. No objections have been raised to the granting of these extensions.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. Notwithstanding any provision of K.C.C. Chapter 6.27 to the contrary, the King County executive is hereby authorized to grant an extension of electrical franchise numbers 595 and 7225 for Seattle City Light through June 30, 1997, in substantially the same form as Attachment "A". Notwithstanding any provision of K.C.C. Chapter 14.44 to the contrary, the executive is also authorized to issue right of way construction permits consistent with terms of the extended franchise. Right of way construction permits issued by the property services division and the roads services division between October 31, 1996 and the date of execution of the franchise extension agreements by King County and the City of Seattle shall be considered issued under the terms of the original franchises and the franchise extension agreements.

SECTION 2. If within sixty days after the granting of these extensions, the grantee shall have failed to sign the franchise extension agreements incorporated herein, then the rights and privileges granted herein shall be forfeited and said franchises shall be null and void. - 2. All other conditions of King County electrical system franchise number 595 shall remain in full force and effect and are not modified by this agreement.
