AN ORDINANCE relating to no shooting areas, establishing a no shooting area near Soos Creek Valley, and adding a new section to K.C.C. 12.68.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. The shooting of firearms is prohibited and a no-shooting area is established near Soos Creek Valley within the Big Soos, Lake Youngs, Soos Creek and North Peak voting precincts and described as follows:

A. 132<sup>nd</sup> Avenue Southeast, Southeast 208<sup>th</sup> Street, 148<sup>th</sup> Avenue Southeast, and Southeast 240<sup>th</sup> Street, in unincorporated King County, commonly called Kent, Washington.




MAP OF PROPOSED NO-SHOOTING ZONE
