6 ORDINANCE NO. 12780

7  
8 AN ORDINANCE extending water system franchise 2199 for the City of  
9 North Bend until November 28, 1998, and authorizing the issuance of  
10 right-of-way construction permits in Council District 12.

12 STATEMENT OF FACTS

- 13  
14 1. The City of North Bend's Franchise 2199, to operate and maintain a water system on  
15 county road rights-of-way, expired on October 20, 1985 and was granted a one-year  
16 extension on September 18, 1994 by Ordinance No. 11499 which expired on September  
17 18, 1995.
- 18  
19 2. The City of North Bend has filed and applied for an application for a water franchise  
20 in Council District 12 to construct, operate, and maintain their existing water system.  
21 When the city obtains council approval of its comprehensive plan, their new franchise  
22 will be submitted.
- 23  
24 3. King County Code Chapter 6.27 requires that the utility franchise application be  
25 approved by the Utilities Technical Review Committee (UTRC) and be consistent with  
26 the county's comprehensive plan, Seattle-King County health department and the State  
27 department of health regulations.
- 28  
29 4. The City is in the process of preparing and obtaining approval of its water  
30 comprehensive plan to bring it in compliance with the state and county regulations. The  
31 City has agreed to submit their plan to the Utilities Technical Review Committee within  
32 one year of the approval of the 18 month extension.
- 33  
34 5. The City has agreed not to issue any new water availability certificates until their  
35 Water System plan and Utility Franchise are approved by King County.
- 36  
37 6. In order to provide the City with the time needed to complete its water plan and to  
38 allow the City to continue to operate and maintain the existing water system on county  
39 road rights-of-way, the City has requested that Franchise 2199 be extended.
- 40  
41 7. The extension for Water Franchise 2199 has been referred to the relevant county  
42 departments for review. No objections to the franchise extension have been raised.
- 43  
44 8. The county executive has recommended approval of the water franchise extension.


BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. Notwithstanding any provision of K.C.C. Chapter 13.24 to the contrary, the King County executive is hereby authorized to grant an extension of Water Franchise 2199 for the City of North Bend until November 28, 1998 in substantially the same form as Attachment "A". Notwithstanding any provision of K.C.C. Chapter 14.44 to the contrary, the executive is also authorized to issue right-of-way construction permits consistent with the terms of the extended franchise.




