2 AN ORDINANCE establishing the date for an
3 election on the question of annexation of
4 the city of Maple Valley to the Maple Valley
5 Fire and Life Safety District (King County
6 Fire Protection District No. 43), and
7 declaring an emergency.

9 FINDINGS OF FACT:

10
11 1. RCW 52.04.071 provides for the county
12 legislative authority, at the city's request, to
13 call a special election to be held in the city
14 and the fire protection district to determine
15 whether the city shall remain annexed to the
16 fire protection district. City of Maple Valley
17 Ordinance No. O-97-17 satisfies the provisions
18 of RCW 52.04.161 and 52.04.071 by requesting the
19 calling of an election by the county council to
20 be held by the qualified voters of the city and
21 the fire protection district.

23 2. The county council notes that Maple Valley
24 Ordinance No. O-97-17 finds that it is in the
25 public interest for the city to be annexed to
26 Maple Valley Fire and Life Safety District
27 (Protection District No. 43).

28
29 3. The Commissioners of Maple Valley Fire and
30 Life Safety District (King County Fire
31 Protection District No. 43) by Resolution 350
32 have concurred with the proposal of the Maple
33 Valley city council to remain annexed to the
34 fire protection district by in accordance with
35 RCW 52.04.161.

36 BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

37 SECTION 1. A special election shall be held on the 16th day
38 of September, 1997, within the city of Maple Valley and in Maple

1 Valley Fire and Life Safety District (King County Fire Protection
2 District No. 43).

3 The ballot proposition shall be in substantially the
4 following form in accordance with RCW 52.04.071:

5 "Shall the city of Maple Valley, Washington be
6 annexed to and be part of Maple Valley Fire and
7 Life Safety District (King County Fire
8 Protection District
9 No. 43)?

10 YES..... []

11 NO..... []"

12 SECTION 2. Notice of election shall be published as
13 required by law.

2 that an emergency exists and that this ordinance is necessary for

4 for the support of county government and its existing public
5 institutions.

CITY OF MAPLE VALLEY, WASHINGTON**ORDINANCE NO. O-97-17**

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF MAPLE VALLEY, WASHINGTON, DECLARING AN INTENT THAT THE CITY BE ANNEXED TO KING COUNTY FIRE PROTECTION DISTRICT NO. 43, AND REQUESTING THAT THE KING COUNTY COUNCIL CALL FOR AN ELECTION IN THE CITY TO PERMIT VOTERS TO DETERMINE WHETHER THE CITY SHALL BE ANNEXED TO AND BECOME A PART OF KING COUNTY FIRE PROTECTION DISTRICT NO. 43 PURSUANT TO RCW 52.04.071

WHEREAS, pursuant to RCW 52.04.061, the process of annexation is initiated by the City Council's adoption of an ordinance stating an intent to annex to the fire protection district and finding that the public interest will be served thereby; and

WHEREAS, the City Council of the City of Maple Valley has reviewed the alternatives for providing fire protection services within the City of Maple Valley and finds that the public interest will be best served by annexation of the City of Maple Valley to King County Fire District No. 43; and

WHEREAS, if the Fire District concurs with the annexation, notification thereof shall be transmitted to the King County Council which shall then call a special election to be held in the City at the time and in the manner provided in RCW 52.04.071; NOW, THEREFORE,

THE CITY COUNCIL OF THE CITY OF MAPLE VALLEY, WASHINGTON, DOES ORDAIN AS FOLLOWS:

Section 1. Finding. The City Council finds that it is in the public interest of the City of Maple Valley to be annexed to King County Fire Protection District No. 43.

Section 2. Declaration of Intent. It is the intent of the City of Maple Valley to be annexed to and become a part of King County Fire Protection District No. 43.

Section 3. Request for Concurrence. Pursuant to RCW 52.04.061, the City requests that the Board of Commissioners of King County Fire Protection District No. 43 concur by resolution in the annexation of the City to the District.

Section 4. Transmittal to County Council and Request for Special Election. Pursuant to RCW 52.04.071, if the Board of Commissioners of King County Fire

Protection District No. 43 concur by resolution with the City's intent to be annexed to and become a part of the District, then the City Clerk is authorized and directed to notify and send a certified copy of this ordinance and the District's resolution to the King County Council. The City requests that the County shall by resolution call for a special election to be held in the City and Fire Protection District No. 43 on September 16, 1997, or at the next date provided in RCW 29.13.010, but not less than forty-five (45) days from the declaration of the finding. The special election shall be held for the purpose of submitting to the qualified voters of the City and the District the proposition of whether the City should be annexed to and become a part of the District. The City further requests that King County shall give notice of the election as provided in RCW 29.27.080. The proposition to be submitted at the special election shall be in the form of a ballot title as follows:

ANNEXATION OF THE CITY OF MAPLE VALLEY TO KING COUNTY FIRE PROTECTION DISTRICT NO. 43

Section 5. Effective Date and Publication. A summary of this ordinance consisting of its title shall be published in the official newspaper of the City. This ordinance shall be effective five days after its passage and publication as provided in RCW 35.02.130.



A Resolution of the Board of Fire Commissioners of
Maple Valley Fire and Life Safety, King County,
Maple Valley, Washington concurring with the City
Maple Valley's intent to annex into said District.

WHEREAS, the City Council of Maple Valley has declared its intent to annex into Maple Valley Fire and Life Safety; and

WHEREAS, the City of Maple Valley has presented Ordinance 0-97-17 to the Fire District, which in part requests the concurrence of the Board of Fire Commissioners; and

WHEREAS, RCW 52.04.061 allows the legislative authority of a city to initiate annexation of a contiguous city to a fire district; and

WHEREAS, 52.04.071 provides the method and requirements for an election for the annexation of a city into a fire district; and

WHEREAS, It is deemed to be in the best interests of the Fire District and the community to have the City of Maple Valley be a part of the Fire District;

BE IT RESOLVED. That the Board of Fire Commissioners of Maple Valley Fire and Life Safety hereby concur with the City Council of Maple Valley and their intent to join the District by annexation; and

BE IT FURTHER RESOLVED. That the officials of King County are hereby requested to call for a special election to be held in conjunction with the September 16, 1997, primary election in the City of Maple Valley and in Fire District #43 for the purpose of a ballot proposition in substantially the following form:

PROPOSITION #1


Shall the City of Maple Valley be annexed to, and be a part of, Maple Valley Fire and Life Safety (King County Fire Protection District #43) effective immediately?




