### ORDINANCE NO. 12882

AN ORDINANCE related to road redesignation; changing the name of 212th Avenue Southeast to "Peregrine Point Way Southeast".

#### PREAMBLE:

This roadway is designated as 212th Avenue Southeast. There is another roadway designated as 212th Avenue Southeast to the north and another roadway designated as 212th Way Southeast which also accesses onto East Lake Sammamish Parkway Southeast. This has caused great confusion in locating homes on all three roads. Application has been received from nine property owners, constituting ninety percent of those property owners whose addresses would be affected, requesting renaming of the entire roadway to "Peregrine Point Way''.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. The roadway designated as "212th Avenue Southeast" described as commencing in a northerly direction from East Lake Sammamish Parkway Southeast and in the east half of Section 17, Township 24 North, Range 6 East, W.M. legal described on Attachment A to this ordinance and shown on Attachment B to this ordinance, is hereby redesignated in its entirety as "Peregrine Point Way Southeast".

SECTION 2. The 20-day notice requirement for affected property owners in Ordinance 10915, Section 2 shall be met.

### PEREGRINE POINT WAY SOUTHEAST ABBREVIATED LEGAL DESCRIPTION


The following described portion of roadway is hereby redesignated as **Peregrine Point** Way Southeast.
