AN ORDINANCE relating to the annexation of a 50.5-acre area known as Lakota Beach to the Lakehaven Utility District for the purpose of providing sewer service.

## STATEMENT OF FACT:

- 1. A notice of intention proposing the annexation of a 50.5-acre area known as Lakota Beach to the Lakehaven Utility District for providing sewer service was filed with the County Council effective March 4, 1997.
- 2. Lakehaven Utility District has found the petition for annexation to be sufficient and has, by Resolution No. 97-818 concurred with the proposed annexation.
- 3. Lakehaven Utility District filed a Determination of Nonsignificance dated November 27, 1996 on the proposed annexation.
- 4. The County Council held a public hearing on the day of October, 1977 and has considered the criteria set forth in R.C.W. 57.02.040.

## BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. The annexation by Lakehaven Utility District of a 50.5-acre area known as Lakota Beach and described in Attachment A, is approved. This proposed annexation is consistent with R.C.W. 57.02.040.

SECTION 2. Lakehaven Utility District is the appropriate entity to serve the area proposed to be annexed.
