ORDINANCE NO. 12913



AN ORDINANCE relating to the annexation of a 15.96-acre area located in Section 6, Township 23 North, Range 4 East to the Southwest Suburban Sewer District for the purpose of providing sewer service.

STATEMENT OF FACT:

- 1. A notice of intention proposing the annexation of a 15.96-acre area located in Section 6, Township 23 North, Range 4 East to the Southwest Suburban Sewer District for sewer service was filed with the county council effective August 18, 1997.
- 2. The Southwest Suburban Sewer District has found the petition for annexation to be sufficient and has, by Resolution No. 97-10, concurred with the proposed annexation.
- 3. The Southwest Suburban Sewer District filed a Determination of Nonsignificance dated May 1, 1997, on the proposed annexation.
- 4. The Utilities Technical Review Committee recommended county council approval of the proposed annexation on September 10,1997.
- 5. The county council held a public hearing on the day of 1917 and has considered the criteria set forth in RCW 57.02.040.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. The annexation by the Southwest Suburban Sewer District of a 15.96-acre area located in Section 6, Township 23 North, Range 4 East and described in Attachment A, is approved. This proposed annexation is consistent with RCW 57.02.040.




