ORDINANCE NO. **12914**

AN ORDINANCE relating to the annexation of a 4.83-acre area, located in Section 5, Township 23 North, Range 4 East, known as Annexation 95-2 to the Val Vue Sewer District for the purpose of providing sewer service.

STATEMENT OF FACT:

1. A notice of intention proposing the annexation of a 4.83-acre area, located in Section 5, Township 23 North, Range 4 East, known as Annexation 95-2 to the Val Vue Sewer District for sewer service was filed with the county council effective June 17, 1996.

2. Val Vue Sewer District has found the petition for annexation to be sufficient and has, by Resolution No. 9601, concurred with the proposed annexation.

3. Val Vue Sewer District filed a Determination of Nonsignificance dated April 26, 1996, on the proposed annexation.

4. The county council held a public hearing on the day of ^{11th} November, 1997 and has considered the criteria set forth in RCW 57.02.040.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. The annexation by Val Vue Sewer District of the 4.83-acre area, located in Section 5, Township 23 North, Range 4 East, known as Annexation 95-2 and described in Attachment A, is approved. This proposed annexation is consistent with RCW 57.02.040.

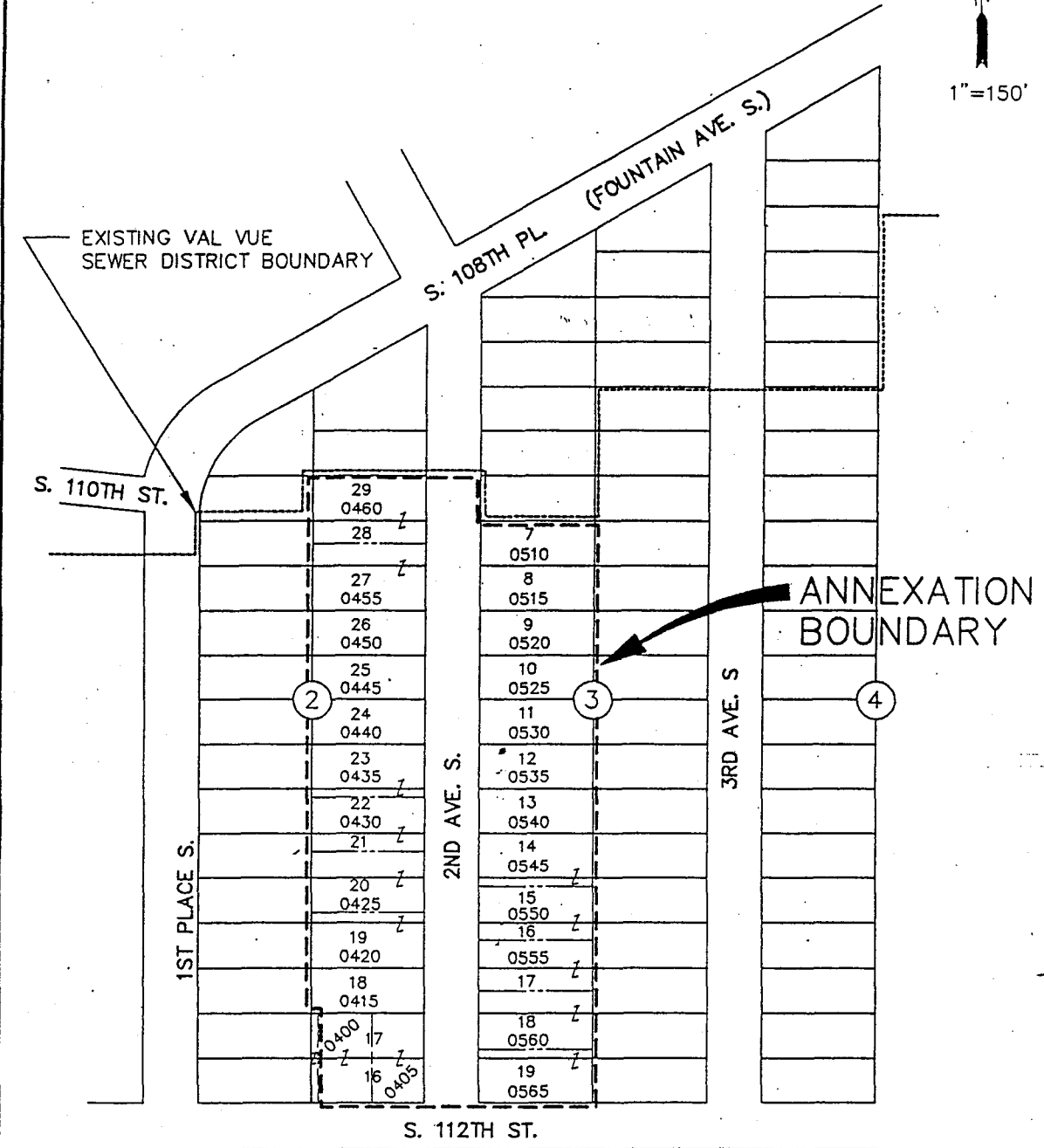
