AN ORDINANCE relating to the establishment of 154th Place Southeast from SR 169 to a point 1025 feet northeasterly of Southeast Jones Road.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. The director of the department of transportation has made an examination of 154th Place Southeast from SR 169, Maple Valley Highway to a point 1025.21 feet northeasterly of Southeast Jones Road along the course and description set forth below and has made a favorable report upon the same, as required by RCW 36.81.050.

SECTION 2. Said road shown on attachment "A" shall be established not less than 84 feet in width, having 42 feet of such width each side of the following described centerline: Commencing at the northwest corner of Section 23, Township 23 North, Range 5 East, Willamette Meridian, situate in the County of King, State of Washington; thence S 0° 20'12'' W 2521.74 feet along the west line of said section, to the west quarter corner of said section; thence S 63°01'31'' E 1411.35 feet to engineer station 0+00, the intersection of the right-of-way centerline of State Route 169 (a.k.a. Maple Valley Highway) and the true point of beginning of a strip of land 84 feet wide, the centerline of which is more particularly described as follows:

Beginning at engineer station 0+00; thence N 14°18'51'' E 18.67 feet to engineer station p.o.t. 0+18.67, the intersection of the as-built centerline of said State Route 169, (Washington State DOT highway station 1385+85.97); thence N 14°18'51'' E 1157.10 feet to engineer station P.C. 11+75.77, the beginning of a curve concave to the southeast, having a radius of 1164.70 feet; thence northeasterly 707.66 feet along said curve through a central angle of 34°48'45'' to engineer station p.t. 18+83.43; thence N 49°07'36'' E 252.78 feet to engineer station 21+36.21, the terminus of said strip of land (engineer station 10+16.60 per W.H. Orton Road as established 3-26-62 per King County Survey Number 23-23-5-6); said terminus being S 58°56'32'' E 2445.18 feet from the northwest corner of said Section 23.
