AN ORDINANCE approving the Soos Creek Water and Sewer District Comprehensive Sewer System Plan.

PREAMBLE:

K.C.C. 13.24 requires approval of comprehensive plans for sewer purveyors as a prerequisite to the granting of right-of-way franchises and approval of right-of-way construction permits.

The Soos Creek Water and Sewer District issued a Determination of Nonsignificance for its Comprehensive Sewer System Plan (Plan) in accordance with the State Environmental Policy Act on December 4, 1996.

The Soos Creek Water and Sewer District adopted the Plan via Resolution 1518-S on January 8, 1997.

The King County Utilities Technical Review Committee (UTRC) met to consider the Plan on July 9, July 23, and August 13, 1997.

One of the projects proposed in the plan, the Witte Road Interceptor project, is currently the subject of a legal challenge.

The UTRC conditionally approved the plan on August 13, 1997. The conditions of approval have been met by the district. The UTRC recommends that the council approve the plan, including the concept of a Witte Road Interceptor Project but not any specific pipeline alignment.

The UTRC further recommends that the council require the district to return to the UTRC with an evaluation of the Witte Road Interceptor project alternatives if the district decides to pursue the rural pipeline alignment. The pipeline alignment alternatives would then be reviewed by the UTRC and a decision of the technical necessity of the proposed rural pipeline alignment would be made in accordance with K.C.C. 13.24.132.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. The Soos Creek Water and Sewer District Comprehensive Sewer System Plan, Attachment A, is hereby approved,

Provided that:

Approval of the Witte Road Interceptor Project contained in the plan constitutes approval of the general project concept only and does not approve any specific pipeline alignment.

SECTION 2. If the district decides to pursue the rural pipeline alignment for the Witte Road Interceptor Project, it shall return to the UTRC with a comparative evaluation of the Witte Road Interceptor Project pipeline alignment alternatives, both urban and rural. The UTRC shall then examine the urban and rural pipeline alignment alternatives and make a determination of the technical necessity of the proposed Rural pipeline alignment per K.C.C. 13.24.132. If the UTRC deems the Rural pipeline alignment to be technically
