ordinance no. 12990

AN ORDINANCE establishing the date for an election to determine whether an area known as Briarwood shall be incorporated as a non-charter code city and declaring an emergency.

PREAMBLE:

Pursuant to the provisions of chapter 35A.03 of the Revised Code of Washington, a petition for incorporation as a non-charter code city, signed by qualified voters resident within the limits of the proposed city equal in number to ten percent of the votes cast in the proposed area at the last preceding general state election has been presented to the King County Records and Elections Division.

The petition for incorporation states that the form of government under which the proposed city will operate in the event it is incorporated shall be Council Manager, sets forth the proposed boundaries of the proposed incorporation, states that the name shall be the City of Briarwood and the number of inhabitants therein as nearly as may be estimated, 9,108 (as of 1996) and prays that it may be incorporated. (This number was subsequently adjusted to 8,779 by the Boundary Review Board for King County which deleted approximately 100 acres from the original proposal.)

The King County superintendent of elections has determined that the petition for incorporation does not violate the prohibitions contained in RCW 35.02.010 with regard to the number of inhabitants and that there are a sufficient number of valid signatures on the petition.

Pursuant to the provisions of RCW 36.93.160 the Boundary Review Board on December 12, 1997, filed its written

decision to modify the action contained in the original Notice of Intention petition. No appeal has been filed to date.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. The King County Boundary Review Board has deemed the matter of an election for incorporation of the city of Briarwood approved as of December 12, 1997.

SECTION 2. The name of the proposed city shall be the city of Briarwood.

SECTION 3. The official population of the proposed city of Briarwood, if incorporated, shall be approximately 8,779.

SECTION 4. An election shall be held on the 10th day of March, 1998, within the area of the proposed city of Briarwood, as hereinafter described, for the purpose of submitting to the qualified electors the determination of whether it shall be incorporated as a non-charter code city, under the Council Manager plan of government proposed in the petition.

SECTION 5. The ballot title for the incorporation shall be drafted by the prosecuting attorney.

SECTION 6. The boundaries of the territory proposed for incorporation are described in exhibit A attached hereto.

SECTION 7. The election shall be conducted pursuant to Title 29 and RCW Chapter 35.02.

SECTION 8. Notice of the election shall be published as required by law. SECTION 9. The council finds as a fact and declares that an emergency exists and that this ordinance is necessary for the immediate preservation of peace, health or safety or for the support of county government and its existing public institutions. Thence South along said East line to the point of intersection with the thread of the Cedar River and the Southeasterly extension of the existing City Limits of Renton, as established by City of Renton Ordinance 4156;

Thence Northwesterly along said Southeasterly extension and existing City Limits, to the East line of Government Lot 4 of said Section 22;

Thence North along said East line to the Southeast corner of Government Lot 5 of said Section 22;

Thence West along the South line and existing City Limits as established by City Ordinance 4156 and the thread of said River as of 1985 to the East line of Government Lot 6 of said Section 22, said line also being the existing City Limits of Renton, as established by City of Renton Ordinance 3945;

Thence North along the East line of Government Lot 6 to the South margin of Southeast 144th Street;

Thence West along said South margin to the South line of the Southwest quarter, of Section 15, Township 23 North, Range 5 East;

Thence West along the South line of said Southwest quarter to the Southwest corner of Maplewood Heights, according to Volume 78 of Plats, Pages 1-4, Records of King County, Washington and the existing Renton City Limits as established by City Ordinance 3945;

Thence following said city limits North along the West line of said Maplewood Heights and its Northerly extension 834 feet more or less;

Thence following said city limits West 655.90 feet more or less to the West line of said Section 15;

Thence following said city limits North along said West line to the South line of the Northwest quarter of the Southwest quarter of said Section 15 and the Renton City Limits, as established by City Ordinance 3143;

Thence following said city limits East along the South line of said Northwest quarter and its East extension to the West line of Tract "A", Hideaway Home Sites, according to Volume 81 of Plats, Pages 88 and 89, records of King County, Washington;

Thence following said city limits Northerly along the West line of said Tract "A" to the South margin of Southeast 136th Street;

Thence easterly along said South margin to the East line of the Southwest quarter of said Section 15;

Thence northerly along said East line to the Northeast corner of said Southwest quarter;

Thence easterly along the South line of the Northeast quarter of said Section 15 to the East margin of 140th Avenue Southeast;

Thence northerly along said East margin to the North line of the South 100 feet of the Southwest quarter of the Northwest quarter of the Northwest quarter of said Section 15;

Thence westerly along said North line to the East line of the Northwest quarter of said Section 15;

Thence north along said East line and the East line of the Southwest quarter of Section 10, of said Township 25 North to the South line of Park Terrace No. 1, according to Volume 65 of Plats, Pages 18 and 19, records of King County, Washington, said line also being the existing City Limits of Renton, as established by City Ordinance 3553 and 4470;

Thence westerly along said South line of Park Terrace and the existing City Limits to the East margin of Duvall Avenue Northeast also known as 138th Avenue Southeast;

Thence north along said East margin to the South margin of Southeast 116th Street said South margin also being the existing City Limits of Renton as established by City Ordinance 4215;

Thence East along said South margin to the West margin of 140th Avenue Southeast and said city limits;

Thence South along said West margin to the point of intersection with the Westerly extension of the North line of Lesh's Church Park according to Volume 77 of Plats, Pages 37 and 38, Records of King County, Washington, and said city limits;

Thence east along said West extension and the North line of said subdivision to the Northeast corner of Lot 8 of said Lesh's Church Park;
