LEGAL DESCRIPTION FOR ANNEXATION NO. 2-94

WATER DISTRICT NO. 90

KING COUNTY, WASHINGTON

BEGINNING at the Northeast corner of the Northwest quarter of the Northeast quarter of Section 12, Township 23 North, Range 5 East, W.M., in King County, Washington, said point being on the existing boundary of King County Water District No. 90;

Thence Southerly along the East line of said Northwest quarter of the Northeast quarter of Section 12 to the North right-of-way line of Southeast May Valley Road;

Thence Easterly along said North right-of-way line to the East line of the West 211.00 feet of the East half of the Northeast quarter of said Section 12;
