ORDINANCE NO. **13399**

AN ORDINANCE appropriating \$205,523 to the City of Seattle Open Space Bond Fund from unappropriated fund balance representing interest earnings on Seattle Open Space Bond Fund balances and allocating these amounts to Seattle open space projects as per interlocal agreement; amending the 1998 Budget Ordinance, Ordinance 12926, Section 115, and Attachment 2, as amended.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. There is hereby approved and adopted an appropriation of \$205,523 to the City of Seattle Open Space Bond Fund from unappropriated fund balance representing interest earnings on Seattle Open Space Bond Fund balances and allocating these amounts to Seattle open space bond projects as per interlocal agreement.

SECTION 2. Ordinance 12926, Section 115, as amended, is hereby amended by adding thereto and inserting therein the following:

From the several capital improvement project funds there are hereby appropriated and authorized to be disbursed the following amounts for the specific projects identified in Attachment 2 of this ordinance:
