### ORDINANCE NO. 13406

AN ORDINANCE relating to the annexation of an area known as the Thomas Annexation Area to King County Water District No. 119 for the purpose of providing water service.

#### STATEMENT OF FACTS:

- 1. A notice of intention proposing the annexation of an area known as Thomas Annexation to King County Water District No. 119 was filed with the county council effective July 10, 1998.
- 2. King County Water District No. 119 has found the petition for annexation to be sufficient and has concurred with the proposed annexation in Resolution No. 343.
- 3. King County Water District No. 119 filed a Determination of Nonsignificance on the proposed annexation dated June 15, 1998.
- 4. The Utilities Technical Review Committee recommended county council approval of the proposed annexation on 3/12/98
- 5. The county council held a public hearing on the day of February, 19 99 and has considered the criteria set forth in RCW 57.02.040.

#### BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. The annexation by King County Water District No. 119 of the area known as the Thomas Annexation Area and described in Attachment A is approved. This proposed annexation is consistent with RCW 57.02.040.




