8	SECTION 2. A special election shall be held on the 18th day of May, 1999, within
9	the City of Milton. The ballot proposition shall be in substantially the following form in
10	accordance with RCW 27.12.370:
11	"Shall the City of Milton be annexed to and be a part of the Pierce County Rural
12	Library District?

15	SECTION 3. If a majority of persons voting on the annexation proposition vote in
16	favor of annexation, the City of Milton shall be annexed to and constitute a part of the
17	Pierce County Rural Library District effective as provided by law.
18	SECTION 4. The manager of the division of records and elections shall cause
19	notice of the proposed annexation to be published in accordance with the State

SECTION 4. The manager of the division of records and elections shall cause notice of the proposed annexation to be published in accordance with the State Constitution and general law and placed on the ballot at the May 18, 1999, election, which is the next election occurring more than forty-five days after enactment of this ordinance. It is requested that the election be held by mail as permitted by chapter 29.36 RCW.
