STATEMENT OF FACTS:

- 1. A notice of intention proposing the transfer of twelve acres from the Sammamish Plateau Water and Sewer District to the Northeast Sammamish Sewer and Water District for the purpose of providing sewer service was filed with the county council effective October 6, 1998.
- 2. Northeast Sammamish Water and Sewer District has found the petition for transfer to be sufficient and has concurred with the proposed transfer in Resolution No. 2971.
- 3. Northeast Sammamish Water and Sewer District adopted the Determination of Nonsignificance on the proposed transfer on September 3, 1998.
- 4. The Utilities Technical Review Committee recommended county council approval of the proposed annexation on December 9, 1998.
- 5. The Boundary Review Board approved the transfer as of November 20, 1998.
- 6. The county council held a public hearing on the day of MAY 3, 1999 and has considered the criteria set forth in RCW 57.02.040.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. The transfer of twelve acres to Northeast Sammamish Water and Sewer District by Sammamish Plateau Sewer and Water described in Attachment A is approved. This proposed annexation is consistent with RCW 57.02.040.


