ORDINANCE NO. 13568

AN ORDINANCE approving the Lakehaven Utility District  
Final Comprehensive Water System Plan Update.

PREAMBLE:

K.C.C. chapter 13.24 requires approval of comprehensive plans for water utilities as a prerequisite for granting right-of-way franchises and approval of right-of-way construction permits.

The Lakehaven Utility District Comprehensive Water System Plan Update (plan) discusses water utility service to the district's ninety-seven thousand existing customers currently living in unincorporated urban areas and portions of the cities of Federal Way, Des Moines, Auburn, Pacific, Milton and Edgewood. The plan also provides water demand forecasts for the next twenty years and includes capital improvement proposals to: secure additional water from the city of Tacoma via a transmission main; continue identification and testing of aquifer storage and recovery sites; improve back-up power supplies, booster pump stations and well pumps; explore use of reclaimed water, including direct injection to aquifer storage and recovery sites; repair and replace water mains; and develop corrosion control programs.

The King County utilities technical review committee (UTRC) reviewed and conditionally approved the plan on April 7, 1999. The conditions of UTRC approval, technical changes to the plan, have been met and are reflected in the final version.

The district prepared a determination of nonsignificance for the plan on November 30, 1998, in accordance with the state Environmental Policy Act.

The district adopted the plan on February 11, 1999.

The UTRC recommends that the council approve the plan.


BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. The Lakehaven Utility District Final Comprehensive Water System Plan Update, Attachment A, is hereby approved without conditions.




