## ORDINANCE NO. 13585

AN ORDINANCE calling for a special election for the purpose of submitting to the affected voters, for their ratification or rejection, the determination of whether or not the City of Milton shall join and be annexed to the Pierce County Rural Library; and declaring an emergency.

## BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

## SECTION 1. Findings of fact:

- A. The City of Milton desires to declare its intention to be annexed to the Pierce County Rural Library District;
- B. Pursuant to RCW 27.12.360, the process of the annexation is initiated by an ordinance of the city council stating the city's intent to join the Pierce County Rural Library District and finding that the public interest will be served thereby;
- C. Pursuant to RCW 27.12.360, the city has submitted that ordinance to the Milton Memorial Library Board for its review and recommendations;
- D. The Milton Memorial Library Board reviewed the resolution and recommended that it be adopted by the city council;
