ORDINANCE NO. 13606

AN ORDINANCE appropriating \$1,711,975 to fund 3292, appropriating \$609,025 to fund 121 and appropriating \$60,000 to fund 105 to implement work programs for the watershed forums as directed by the King County council in Ordinance 12959; and amending the 1999 Budget Ordinance, Ordinance 13340, Section 119, Attachment 3, and Sections 82 and 73, each as amended.

STATEMENT OF FACTS:

1. On December 15, 1997, the King County Council passed Ordinance 12959 which increased the assessment for the King Conservation District and changed the district's distribution formula. Ordinance 12959, Section 3, requires that:

The district shall distribute a total of \$3 per parcel in equal amounts to each of the four watershed forums and the Puget Sound forum should it be established. The watershed forums shall be free to determine, based on their own rules, how they wish to spend these funds, provided that they are spent within the boundaries of the King Conservation District and consistent with the purposes of the district as established in chapter 89.08 RCW, and provided that the uses are consistent with regional funding principles approved by the regional water quality committee.

2. In compliance with Ordinance 12959, the five watershed forums have selected and approved the allocations included in this supplemental ordinance. These allocations will be spent within the King Conservation District boundaries and are consistent with the purposes of the King Conservation District, and the regional funding principles approved by the regional water quality committee.

1 BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

2 SECTION 1. There is hereby approved and adopted appropriations of \$1,711,975
 3 to CIP fund 3292. See Attachment 1.

4 SECTION 2. There is hereby approved and adopted appropriations of \$609,025 to
 5 fund 121. See Attachment 2.

6 SECTION 3. There is hereby approved and adopted appropriations of \$60,000 to
 7 fund 105. See Attachment 3.

 9 amended by adding thereto and inserting therein the following:




