1	AN ORDINANCE relating to the annexation of
2	approximately twelve acres into the Lakehaven Utility
3	District Corporate and Sewer Service Area boundaries for
4	the purpose of providing sanitary sewer service.

6	STATEMENT OF FACTS:
7	1. A notice of intention proposing the annexation of approximately
8	twelve acres into the Lakehaven Utility District for the purpose of
9	providing sanitary sewer service was filed with the county council
10	effective December 15, 1999.
11	2. Lakehaven Utility District has found the petition for annexation to be
12	sufficient and has concurred with the proposed transfer in Resolution No.
13	99-907, passed November 18, 1999.
14	3. Lakehaven Utility District acknowledged completion of its
15	Environmental Review on the proposed transfer in Resolution No. 99-
16	907 and filed a Determination of Nonsignificance dated October 6, 1999
17	in its Notice of Intention.

18	4. The Utilities Technical Review Committee recommended county
19	council approval of the proposed annexation on January 17, 2000.
20	5. The county council held a public hearing on the 28th day of February,
21	2000 and has considered the criteria set forth in RCW 57.02.040.
22	BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:
23	SECTION 1. The annexation of twelve acres to Lakehaven Utility described in
24	Attachment A is approved. This proposed annexation is consistent with RCW 57.02.040.
25	SECTION 2. Lakehaven Utility District is the appropriate entity to serve the area
26	proposed to be annexed.

SECTION 3. 
