7 \$192,209 to the airport from the airport fund for overtime,

11 27, 39, 42, 43 and 101, as amended.

14 **BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:**

16 of \$1,300,000 to the sheriff, \$178,250 to the office of emergency management, \$90,276
17 to facilities management, \$90,276 to CX fund transfers and \$299,827 to adult detention
18 from the current expense fund for personnel overtime and other extraordinary expenses

19 resulting from the World Trade Organization conference.






