King County's child care program provides homeless child care services, 8 as directed by Motion 7514. 9 2. Anticipated federal funds for homeless child care services were not 10 renewed in 2000. 11 3. The D.V. and Ida McEachern Charitable Trust learned of the shortfall 12. and made an extremely generous gift of forty thousand dollars, to be 13 applied to child care services for homeless children in King County. 14 BE IT ORDAINED BY THE COUNCIL OF KING COUNTY: 15 SECTION 1. There is hereby approved and adopted a supplemental appropriation 16 17 of \$40,000 to grants from funds provided by the D.V. and Ida McEachern Charitable Trust

The trustees and advisory committee of the D.V. & Ida McEachern Charitable Trust met yesterday ,to review proposals submitted for the winter 1999 funding cycle. As we discussed by phone, we are pleased to make a grant award to the King County Child Care Program in the amount of \$40,000.00. The grant flinds are to be applied to 501(C)3 nonprofit agencies in the Greater Seattle area that provide child care services for homeless children.

Please confirm receipt of these funds by signing the enclosed copy of this letter and returning it in the self-addressed, pre-paid envelope. Also, please let us know how the funds were distributed through your agency.

In this funding cycle, the McEachem Trust granted a total of \$13 1,000 to seven organizations serving children in the Puget Sound area. They ranged in size from \$5,000 to purchase science equipment for the youth environmental education program Salish Sea Expeditions - to \$50,000 for the Valley Cities Counseling and Consultation capital campaign to provide mental health services for children in South King County. Capital gifts of \$25,000 were awarded to the Good Samaritan Community Healthcare's Children's Therapy Unit, and to the Rainshadow Natural Science Program in Sequirn to construct a Natural History Center.

We enjoyed learning about your work, and look forward to hearing about the progress of your project in the year ahead. At the end of your one-year grant period, please provide the Trust with a brief evaluation summary - let us know what worked well, and what challenges you faced.
