7	STATEMENT OF FACTS:
8	1. In 1993, the King County council passed Ordinance 11169 establishing
9	South 277th Street through unincorporated King County in the vicinity of
10	the city of Kent. The ordinance specified conditions to be met by the city
11	and King County before the effective date of the establishment.
12	2. Plans and descriptions for the new right-of-way were developed by the
13	city of Kent and approved by King County and, in 1994, the two
14	jurisdictions finalized an interlocal agreement by which the city assumed
15	responsibility for the project.
16	3. The South 272nd/277th Street corridor project includes widening South
17	277th Street and extending it easterly to the Green River. The project will

18	reduce traffic delays, improve public safety and provide pedestrian and
19	bicycle facilities.
20	4. The project requires the use of 9.53 acres of farmland preservation
21	program (FPP) property. K.C.C. 26.04.030A authorizes the county
22	council to convey public road and utility easements across FPP property.
23	5. The city of Kent will compensate King County at fair market value for
24	its FPP interest in the required property.
25	6. If necessary, the city of Kent is prepared to acquire the county's interest
26	in the 9.53 acres needed for the project through eminent domain.
27	BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:
28	SECTION 1. The King County executive is hereby authorized, under
29	threat of eminent domain, to convey King County's interest in the lands, as
30	described in Attachments A and B to this ordinance, to the city of Kent for the
31	South 272nd/277th Street corridor project.
32	SECTION 2. The King County executive is hereby authorized to accept
33	compensation for King County's interest in the lands, as described in Attachments
34	A and B to this ordinance, that are conveyed to the city of Kent for the South
35	272 nd /277th Street corridor project. Said compensation will be used to purchase
36	development rights on additional farmland to replace that used for the South
37	272 nd /277th Street corridor project. If feasible, the replacement development

rights will be on farmland within the lower Green River agricultural production district.

That portion of Section 36, Township 22 North, Range 4 Fast, W.M. and Sections 30 and 31, Township 22 North, Range 5 East, W.M. in King County, Washington described as follows

Commencing at the southeast corner of the R.H. Beatty D L.C. Numbers 37 and 44 which point is also the northeast corner of the W.A. Cox D.L.C. Number 38 and the northwest corner of the G.E. King D L.C. Numbers 37 and 44, thence North 90"34"56" Fast 49 50 feet along the east line of said Beatty D L C to the north line of South 277th Street (AKA) 52nd Street NE; thence North 88°59'37" West 1,543.96 feet along said north line in the POINT OF BEGINNING, thence North \$8"39"57" West 749 49 feet along said north line NB 31-12-4 to the east line of Fast Valley Highway (AKA) Custral Avenue South, thence North 01"0003" Fast along the east line thereof a distance of 6.89 fest; thence North 79°59'33" West along said east line 186 21 feet; to a point on a curve northeasterly the radius of which bears North 73"31"03" East 2,810.06 feet; thence along said curve an are distance of 49.87 feet through a central angle of 01"01"01" and the beginning of a curve concave northeasterly the radius of which bears North 01°00'03° East 50 00 feet; thence snutheasterly along said curve an arc distance of 63.28 feet through a central angle of 72°31'01", thence South 88°59'57" East 856 27 feet; to a point of tangency of a curve concave northwesterly having a radius of 25.00 feet, thence along said curve an are distance of 45 60 feet to the west line of 86th Avenue South, thence South 13"31"01" East along said west line a distance of \$2.40 feet to the POINT OF BEGINNING

Attachment B. Legal Description Parcel 47

That portion of Section 31, Township 22 North, Range 5 East, W.M., in King County, Washington described as follows:

Beginning at the northeast corner of the W.A. Cox D.L.C. Number 38, which point is also the southeast corner of the R.H. Beatty D.L.C. Numbers 37 and 44 and the northwest corner of the G.E. King D.L.C. Number 40; thence along the east line of said Beatty D.L.C. North 00°34′56″ East 98.00 feet; thence South 89°40′09″ East 817.74 feet; thence North 86°05′27″ East 268.24 feet; thence North 86°15′30″ East 649.93 feet; thence North 80°41′15″ East 274.09 feet more or less to a point on the southwesterly property line of that portion conveyed to King County and recorded under King County Auditor's File Number 8003079002; thence South 46°26′33″ East along said southwesterly line 344.99 feet to the north line of said G.E. King D.L.C.; thence North 88°59′57″ West along said north line 2,255.72 feet to the POINT OF BEGINNING.
