5	STATEMENT OF FACTS:
6	1. A petition has been filed requesting vacation of that portion of
7	Northeast 124th Street hereinafter described.
8	2. The department of transportation notified the various utility
9	companies serving the area and has been advised easements were not
10	required within the vacation area.
11	3. The proposed road vacation is pursuant to a condemnation settlement
12	agreement between King County, property services division and the
13	petitioner. The agreement, which was negotiated by the King County
14	prosecuting attorney's office, was in conjunction with the construction of
15	Northeast 124th Street, Phase II. The agreement provides for the trade of
16	surplus county-owned property along Northeast 124th Street for needed

17	right-of-way and certain easement rights for the construction of the
18	Northeast 124th Street road project.
19	4. The department of transportation records indicates that King County
20	acquired the Northeast 124th Street right-of-way on November 10, 1964,
21	by quit claim deed recorded in Volume 4596 of Deeds, Page 654, under
22	recording number 5809825, records of King County. King County paid
23	the total sum of \$600 in consideration for the conveyance. The records
24	disclosed that the county is maintaining Northeast 124th Street.
25	5. With the new construction alignment of Northeast 124th Street the
26	department of transportation considers the proposed vacation area of the
27	right-of-way useless as part of the county road system and believes the
28	public would benefit by the return of this unused area to the public tax
29	rolls.
30	6. The right-of-way is classified as "A-Class" and, in accordance with
31	K.C.C. 14.40.020, the compensation due King County is based on one
32	hundred percent of the assessed value of the subject right-of-way which
33	was determined from records of the department of assessments. In
34	accordance with K.C.C. chapter 14.40, compensation in the amount of
35	\$15,930 is due the county for that portion of the road to be vacated. The
36	compensation for vacating the 3,540 square feet is based on the assessed
37	value as determined from the records of the department of assessments.

38	7. The terms of the settlement agreement provides that if the King
39	County council does not approve the trade and road vacation, the county
40	will pay the petitioner \$75,621.10 in monetary compensation.
41	8. The road services division has determined that the value of the
42	replacement right-of-way for the construction of Northeast 124th Street
43	exceeds the value of the compensation for the vacation area.
44	9. The road services division recommends that the council accept the
45	value of the replacement rights-of-way in lieu of compensation for
46	vacating portions of Northeast 124th Street. In accordance with K.C.C.
47	14.40.020D, the council may waive some or all of the compensation for
48	any classification of road if it determines that it would benefit King
49	County to do so.
50.	Due notice was given in the manner provided by law and a hearing was
51	held by the office of the hearing examiner on the 13th day of October,
52	2000.
53	In consideration of the benefits to be derived from the subject
54	vacation, the council has determined that it is in the best interest of the
55	citizens of King County to grant said petition.
56	BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:
57	SECTION 1. The council, on the 8th day of January, 2001, hereby vacates and
58	abandons that portion of Northeast 124th Street as conveyed to King County by Quit-
59	Claim Deed recorded in Volume 1151 of Deeds, Page 105, records of King County,
60	Washington described as follows:

51	That portion of Northeast 124th Street as conveyed to King County
62	for road purposes under Recording Number 5809825; in Volume 1151 of
63	Deeds, Page 105, records of King County, Washington, lying Southerly of
64	a line 50 feet South of, as measured at right angles to, and parallel with the
65	centerline of Northeast 124th Street as shown in King County Survey 28-
66	26-5-50, and opposite Engineer's Station 125+00 and 129+00 of said
67	survey.
68	Reserving unto King County wall easements over, under, through, and
69	across the above described vacation area to construct, alter, repair, and
70	maintain a retaining wall with appurtenances including subsurface soil-
71	nailed staples and tiebacks.
72	The wall easements being that portion of the vacation area lying North of
73	the following described line.
74	Beginning at a point, said point being at Engineers Station 124+65.57,
75	right 59.5 feet as measured from the centerline of Northeast 124th Street,
76	as shown in King County Survey No. 28-2-5-50.
77	Thence Easterly along a line to a point, said point being at Engineers
78	Station 125+62.00, right 68 feet measured from said centerline.
79	Thence Easterly along a line to a point, said point being Engineers Station
80	126+28.87, right 58 feet as measured from said centerline.
81	Containing an area of 1678 square feet or 0.039 acres, more or less.

### STATEMENT OF FACTS:

- 1. A petition has been filed requesting vacation of that portion of
   Northeast 124th Street hereinafter described.
  - 2. The department of transportation notified the various utility companies serving the area and has been advised easements were not required within the vacation area.
  - 3. The proposed road vacation is pursuant to a condemnation settlement agreement between King County, property services division and the petitioner. The agreement, which was negotiated by the King County prosecuting attorney's office, was in conjunction with the construction of Northeast 124th Street, Phase II. The agreement provides for the trade of surplus county-owned property along Northeast 124th Street for needed

right-of-way and certain easement rights for the construction of the Northeast 124th Street road project.

- 4. The department of transportation records indicates that King County acquired the Northeast 124th Street right-of-way on November 10, 1964, by quit claim deed recorded in Volume 4596 of Deeds, Page 654, under recording number 5809825, records of King County. King County paid the total sum of \$600 in consideration for the conveyance. The records disclosed that the county is maintaining Northeast 124th Street.
- 5. With the new construction alignment of Northeast 124th Street the department of transportation considers the proposed vacation area of the right-of-way useless as part of the county road system and believes the public would benefit by the return of this unused area to the public tax rolls.
- 6. The right-of-way is classified as "A-Class" and, in accordance with K.C.C. 14.40.020, the compensation due King County is based on one hundred percent of the assessed value of the subject right-of-way which was determined from records of the department of assessments. In accordance with K.C.C. chapter 14.40, compensation in the amount of \$15,930 is due the county for that portion of the road to be vacated. The compensation for vacating the 3,540 square feet is based on the assessed value as determined from the records of the department of assessments.
