1	AN ORDINANCE relating to the annexation of an area
2	known as Island Annexation Area (Annexation #2000-1) to
3	Val Vue Sewer District for the purpose of providing sewer
4	service.
5	
6	STATEMENT OF FACTS:
7	1. A notice of intention proposing the annexation of an area known as
8	Island Annexation Area (Annexation #2000-1) for sewer service was
9	filed with the county council on December 1, 2000.
10	2. Val Vue Sewer District has approved the proposed annexation in
11	Resolution No. 2000-13.
12	3. Val Vue Sewer District issued a Determination of Nonsignificance on
13	the proposed annexation dated September 6, 2000.
14	4. The Utilities Technical Review Committee recommended county
15	council approval of the proposed annexation on February 9, 2000.
16	5. The county council held a public hearing on January 29, 2001 and has
17	considered the criteria set forth in RCW 57.02.040(3).

18	BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:
19	SECTION 1. Findings. The county council finds that:
20	A. The proposed action is in compliance with the county's Comprehensive Plan;
21	B. The proposed action is in compliance with basinwide water or sewage plan, or
22	both, as approved by the state department of ecology and the state department of social
23	and health services; and
24	C. The proposed action is in compliance with the policies expressed in the
25	county's plan for water or sewage facilities, or both.
26	SECTION 2. After consideration of the criteria listed in RCW 57.02.040(3), the
27	annexation by Val Vue Sewer District of the area known as the Island Annexation Area
28	(#2000-1) and described in Attachment A to this ordinance is consistent with those
29	criteria and is approved. Pursuant to RCW 57.02.045, this approval is final unless review
30	is taken by the King County boundary review board under chapter 36.93 RCW.
31	SECTION 3. Val Vue Sewer District is the appropriate entity to serve the area
32	proposed to be annexed.

33	SECTION 4. Completion of this annexation does not constitute county approval
34	or disapproval of any other permits, certifications or actions necessary to provide service
35	to this annexation area.




A. General Legal Description for the Val Vue Sewer District - Island Annexation, B.

GENERAL LEGAL DESCRIPTION FOR THE VAL VUE SEWER DISTRICT – ISLAND ANNEXATION

Being portions of Sections 3, 4, 5, 8, 9,10, 14, 15,16, 17, 21, 22,26, 27, 28, and 34, Township 23 North and Section 32, Township 24 North all in Range 4, W.M., King County, Washington, described as follows:

The West half of the West half lying Southerly of the thread of the Duwamish River, and lying Westerly of Primary State Highway No. 1, in Sections 10, Township 23, lying westerly and Southerly of 42nd Avenue South, South 135th Street, and SR 599 in Section 15 and 14, lying Northerly and Southerly of SR 518 in the East half of Section 22. lying Southerly of South 160th Street in Section 27, being the Southwest quarter of the Southwest quarter of the Northwest quarter of Section 26, and lying Westerly of SR 5 in the Southwest quarter of Section 26 and the Northwest quarter of Section 35, lying Northerly of South 182nd Street in the East half of the Northeast quarter of Section 34, lying North of South 176th Street in Section 27, lying Easterly of Pacific Highway South in Section 28, lying Northerly of South 154th Street in the Northeast quarter of the Southeast and North of South 152nd Street East of 24th Avenue South, the North half of the North half of the Northwest quarter of Section 21 lying West of 24th Avenue South, lying Easterly of South 142 Place and North of South 142 Street in Section 16, being the south line of the Northeast quarter of the Northeast quarter of the Southeast quarter of Section 17 and the South line of the Northeast quarter of Section 17 East of SR 509 in the Northwest quarter of Section 17 and the Southwest quarter of Section 8, being the West line of the East half of the East half of the West half and the West line of East 3/4 of the Southeast quarter of Section 8, being the North line of the South half and lying Easterly of 10th Avenue South in the Northeast quarter of Section 8, being the East margin of Secondary State Highway No. 1-K in the Northwest quarter of Section 8, being the North margin of South 112th Street west of 8th Avenue South in the Southwest quarter of Section 5, being the East margin of 1st Avenue South lying South of South 100th Street and the West margin of SR 509 in the Northwest quarter of Section 5, being the East margin of SR 509 in the South half of the Southwest quarter of Section 32, Township 24, being the North line of the South half of the South half and the East line of the East half and the South line of S Director Street in the Southeast quarter of Section 32, being the South line of the existing city limits of Seattle lying westerly of the Duwamish Waterway in Section 33, being the West margin of the Duwamish Waterway lying North of the centerline of SR 99 in Section 4, Township 23, and the centerline of SR 99 in the Southeast quarter of the Northwest quarter of Section 4, being the thread of the Dumamish River in the Northeast quarter of Section 4, lying Westerly of the West margin of the Northern Pacific Railroad Right of way in the Southwest quarter of Section 3, and being the West line of the Northeast quarter of the Northeast quarter of the Northwest quarter of Section 10 lying North of the thread of the Duwamish River.
