12	forward from 2000, and \$1,554,211 from the current expense salary and wage		
13	contingency, and an appropriation of \$150,000 from the criminal justice fund to		
14	sheriff/CJ, implementing the collective bargaining agreement negotiated between King		
15	County and the King County Police Officers' Guild.
