7		STATEMENT OF FACTS:
8		1. A notice of intention proposing the annexation of approximately
9		93.84 acres of land known as Palisades into the Lakehaven Utility
10	·	District for the purpose of eventually providing sanitary sewer service
11		was filed with the county council effective April 27, 2001.
12		2. Lakehaven Utility District has found the petition for annexation to be
13		sufficient and has concurred with the proposed annexation in Resolution
14	~	No. 2001-944, passed on April 12, 2001.
15		3. Lakehaven Utility District filed a Determination of Nonsignificance
16		on the proposed annexation dated March 5, 2001.
17		4. The Utilities Technical Review Committee recommended county

18	council approval of the proposed annexation on May 9, 2001.	
19	5. The county council held a public hearing on June 4, 2001 and has	
20	considered the criteria in RCW 57.02.040.	
21	BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:	
22	SECTION 1. The annexation of approximately 93.84 acres of land into	
23	Lakehaven Utility District for the purpose of eventually providing sanitary sewer service	
24	described in Attachment A of this ordinance is approved. This proposed annexation is	
25	consistent with RCW 57.02.040.	
26	SECTION 2. Lakehaven Utility District is the appropriate entity to serve the area	
27	proposed to be annexed.	

SECTION 3. Completion of this annexation does not constitute county approval or disapproval of any other permits, certifications or actions necessary to provide service to this annexation area.

EXHIBIT "A"

LEGAL DESCRIPTION

PALISADES ANNEXATION (SW Dash Point Road/47th Avenue SW To Dumas Bay Park) CORPORATE AND SEWER ONLY

That portion of Section 11, Township 21 North, Range 3 East, W.M., King County, Washington, described as follows:

That portion of the North half of the Northwest quarter of the Southwest quarter of said Section 11, lying northeasterly of the centerline of Puget Sound Marine View Drive. (Tax Parcel No. 112103-9077)

AND the West 60 feet of that portion of the Northeast quarter of the Southwest quarter of said Section 11, lying northerly of the centerline of Puget Sound Marine View Drive. (Tax Parcel No. 112103-9087)

AND all of Government Lot 3 of said Section 11 lying southerly of the Government Meander Line.

EXCEPT the South 523 feet of the East 596.64 feet thereof.

(Tax Parcel Nos. 112103-9005, 112103-9009, 112103-9010, 112103-9029, 112103-9030, 112103-9031, 112103-9045, 112103-9059, 112103-9071, 112103-9078, 112103-9080, 112103-9081, 112103-9084, 112103-9088, 112103-9093, 112103-9097, 112103-9104, 112103-9105, 112103-9108, 112103-9110, 211600-0010, 211600-0020, 211600-0030, 211600-0040, 211600-0050, 211600-0060, 211600-0070, 211600-0080, and 211600-0090)

AND all of Government Lot 2 of said Section 11 lying southerly of the Government Meander Line,

EXCEPT that portion lying southerly of the northerly margin of Puget Sound Marine View Drive (also known as SW Dash Point Road),

AND EXCEPT the South 523 feet of the West 800 feet thereof, lying northerly of the northerly margin of Puget Sound Marine View Drive,

AND EXCEPT that portion within the plat of Schade Palisade Beach Estate Addition, according to the plat thereof recorded in Volume 68 of Plats, Pages 51 and 52, records of King County, Washington.


