6	STATEMENT OF FACTS:
7	1. A petition has been filed requesting vacation of that portion of C. L.
8	Morris Road (County Road 964) hereinafter described.
9	2. The department of transportation notified the various utilities
10	companies serving the area and has been advised that Puget Sound Energy
11	has secured an easement within the vacation area. No other easements
12	were required.
13	3. The department of transportation, traffic engineering section,
14	recommends that King County retain a 45-foot radius curve tangent to the
15	south right-of-way line of Northeast 124th Street and tangent to the west
16	margin line of 156th Avenue Northeast (SR 202) for construction of future
17	curbs.

18	4. King County records indicate that C. L. Morris Road (County Road
19	964) was established on October 14, 1913. C. D. Stimson deeded the
20	right-of-way as a 60-foot strip of land right-of-way on March 18, 1914.
21	King County paid the Stimsons \$375 in consideration for the public road
22	through their property. Therefore this portion of C. L. Morris Road
23	(County Road 964) is classified as an "A" Class road vacation.
24	5. The original petition requested King County to vacate the southeast 30
25	feet of the C. L. Morris Road (County Road 964).
26	6. In the road services division investigation of the petition, it was found
27	that there is a public need for the northwesterly 30 feet of the right-of-way
28	which abuts two parcels of land. One parcel of land is currently in the
29	farmland preservation program. The second parcel of land is owned by
30	King County, which was acquired in 1994 under Recording Number
31	9412010369, records of King County, Washington. The purpose of that
32	acquisition was for the construction of new stream channel in conjunction
33	with the Northeast 124th Street road-widening project.
34	7. The farmland preservation office recommended that the property
35	owners of the farmland parcel become a party to the petition and that the
36	development rights be reserved in the road vacation. It was also
37	recommended that the portion of the northwesterly 30 feet C. L. Morris
38	Road (County Road 964) that abuts the King County parcel be included in
39	the road vacation.

40	8. The records indicate that King County has not maintained the subject
41	portion of the C. L. Morris Road (County Road 964).
42	9. The department of transportation considers the subject portion of the
43	right-of-way useless as part of the county road system and believes the
44	public would benefit by the return of this unused area to the public tax
45	rolls.
46	10. In accordance with K.C.C. 14.40.020, the compensation due King
47	County for vacating an "A" Class road is based on 100 percent of the
48	assessed value of the subject right-of-way which was determined from
49	records of the department of assessments. King County is in receipt of
50	\$32,426.97 from the petitioners.
51	11. The road services division recommends that the council waive the
52	compensation for that portion of the subject road that attaches to the parcel
53	of land that is owned by King County, road services division. "A" class
54	compensation is paid to the road services division.
55	12. Due notice was given in the manner provided by law and a hearing
56	was held by the office of the hearing examiner on the 21st day of June,
57	2001.
58	13. In consideration of the benefits to be derived from the subject
59	vacation, the council has determined that it is in the best interest of the
60	citizens of King County to grant said petition.

DEPARTMENT'S REPORT:

The Department of Transportation's written report to the King County Hearing Examiner for Item No. V-2414 was received by the Examiner on June 4, 2001.

PUBLIC HEARING:

After reviewing the Department of Transportation's Report and examining available information on file with the petition, the Examiner conducted a public hearing on the subject as follows:

The hearing on Item No. V-2414 was opened by the Examiner at 1:28 p.m., June 21, 2001, in the 5th Floor Conference Room, Union Bank of California Building, 900 – 4th Avenue, Seattle, Washington, and closed at 1:35 p.m. Participants at the public hearing and the exhibits offered and entered are listed in the attached minutes. A verbatim recording of the hearing is available in the office of the King County Hearing Examiner.

<u>FINDINGS</u>, <u>CONCLUSIONS & RECOMMENDATION</u>: Having reviewed the record in this matter, the Examiner now makes and enters the following:

FINDINGS:

1. General Information:

- 2. Except as provided below, the Examiner adopts and incorporates herein by this reference the facts set forth in the Department of Transportation's report to the King County Hearing Examiner for the June 21, 2001 public hearing and the statement of facts contained in Proposed Ordinance No. 2001-0263. The Department's report will be attached to those copies of this report and recommendation that are submitted to the Metropolitan King County Council.
- 3. Maps showing the vicinity of the proposed vacation and the specific area to be vacated are Exhibit 19 to this Report and Recommendation.
- 4. Vacation of the subject right-of-way would have no adverse effect on the provision of fire and emergency services to the subject property or surrounding area.

CONCLUSIONS:

- 1. The road subject to this petition is useless as part of the King County road system, and the public will be benefited by its vacation.

NOTICE OF RIGHT TO APPEAL AND ADDITIONAL ACTION REQUIRED

In order to appeal the recommendation of the Examiner, written notice of appeal must be filed with the Clerk of the King County Council with a fee of \$125.00 (check payable to King County Office of Finance) on or before **July 9, 2001**. If a notice of appeal is filed, the original and 6 copies of a written appeal statement specifying the basis for the appeal and argument in support of the appeal must be filed with the Clerk of the King County Council on or before **July 16, 2001**. Appeal statements may refer only to facts contained in the hearing record; new facts may not be presented on appeal.

Filing requires actual delivery to the Office of the Clerk of the Council, Room 1025, King County Courthouse, prior to the close of business (4:30 p.m.) on the date due. Prior mailing is not sufficient if actual receipt by the Clerk does not occur within the applicable time period. The Examiner does not have authority to extend the time period unless the Office of the Clerk is not open on the specified closing date, in which event delivery prior to the close of business on the next business day is sufficient to meet the filing requirement.

If a written notice of appeal and filing fee are not filed within 14 days calendar days of the date of this report, or if a written appeal statement and argument are not filed within 21 calendar days of the date of this report, the Clerk of the Council shall place a proposed ordinance which implements the Examiner's recommended action on the agenda of the next available Council meeting. At that meeting, the Council may adopt the Examiner's recommendation, may defer action, may refer the matter to a Council committee, or may remand to the Examiner for further hearing or further consideration.

Action of the Council Final. The action of the Council on a recommendation of the Examiner shall be final and conclusive unless within twenty-one (21) days from the date of the action an aggrieved party or person applies for a writ of certiorari from the Superior Court in and for the County of King, State of Washington, for the purpose of review of the action taken.

FINDINGS:

- 2. - 3. Maps showing the vicinity of the proposed vacation and the specific area to be vacated are Exhibit 19 to this Report and Recommendation.
- 4. Vacation of the subject right-of-way would have no adverse effect on the provision of fire and emergency services to the subject property or surrounding area.

CONCLUSIONS:

- 1. The road subject to this petition is useless as part of the King County road system, and the public will be benefited by its vacation.
- 2. The Notice of Hearing on the report of the Department of Transportation was given as required by law, and a hearing on the report was conducted by the King County Hearing Examiner on behalf of the King County Council.

NOTICE OF RIGHT TO APPEAL AND ADDITIONAL ACTION REQUIRED

In order to appeal the recommendation of the Examiner, written notice of appeal must be filed with the Clerk of the King County Council with a fee of \$125.00 (check payable to King County Office of Finance) on or before **July 9, 2001**. If a notice of appeal is filed, the original and 6 copies of a written appeal statement specifying the basis for the appeal and argument in support of the appeal must be filed with the Clerk of the King County Council on or before **July 16, 2001**. Appeal statements may refer only to facts contained in the hearing record; new facts may not be presented on appeal.

Filing requires actual delivery to the Office of the Clerk of the Council, Room 1025, King County Courthouse, prior to the close of business (4:30 p.m.) on the date due. Prior mailing is not sufficient if actual receipt by the Clerk does not occur within the applicable time period. The Examiner does not have authority to extend the time period unless the Office of the Clerk is not open on the specified closing date, in which event delivery prior to the close of business on the next business day is sufficient to meet the filing requirement.

If a written notice of appeal and filing fee are not filed within 14 days calendar days of the date of this report, or if a written appeal statement and argument are not filed within 21 calendar days of the date of this report, the Clerk of the Council shall place a proposed ordinance which implements the Examiner's recommended action on the agenda of the next available Council meeting. At that meeting, the Council may adopt the Examiner's recommendation, may defer action, may refer the matter to a Council committee, or may remand to the Examiner for further hearing or further consideration.

Action of the Council Final. The action of the Council on a recommendation of the Examiner shall be final and conclusive unless within twenty-one (21) days from the date of the action an aggrieved party or person applies for a writ of certiorari from the Superior Court in and for the County of King, State of Washington, for the purpose of review of the action taken.
