1	AN ORDINANCE relating to property services division
2	fees; increasing fees for permits for public and private
3	utilities; increasing fees for special use permits; increasing
4	fees for fees right-of-way franchises for utilities; and
5	increasing fees for permits for public and private utilities;
6	and amending Ordinance 10171, Section 1, as amended,
7	and K.C.C. 6.27.054, Ordinance 6254, Section 6, as
8	amended, and K.C.C. 14.30.060, Ordinance 1711, Section
9	4, as amended, and K.C.C. 14.44.040 and Ordinance 4099,
10	Section 8, as amended, and K.C.C. 14.46.080 and adding a
11	new section to K.C.C. chapter 14.44.

14	BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:
15	SECTION 1. A. Section 2 of this ordinance proposes changes in the fees
16	currently charged for applications for right-of-way franchises for utilities.
17	B. These fees are assessed pursuant to K.C.C. 2.99.030.

18	SECTION 2. Ordinance 10171, Section 1, as amended, and K.C.C. 6.27.054 are
19	each hereby amended as follows:
20	Franchise application and advertising fees. A. Effective January 1, ((1999))
21	2002, a party requesting a new franchise, amended franchise, renewal, extension of an
22	existing franchise or transfer shall pay a franchise application fee of one thousand four
23	hundred dollars as reimbursement to King County for the administrative costs and
24	expenses incurred in the processing of the franchise application. The franchise
25	application fee is payable at the time the application is filed with the clerk of the council.
26	In addition, each applicant shall pay the full advertising costs associated with the
27	application. Franchise application and advertising fees are not refundable, even if the
28	application is disapproved.
29	B. All franchise application payments received shall be credited to the county
30	current expense fund.
31	C. This section shall not apply to franchise applications, renewal, amendments or
32	transfers made under the county's cable television regulations, K.C.C. chapter 6.27A.
33	SECTION 3. A. Section 4 of this ordinance proposes changes in the fees
34	currently charged for special use permits.
35	B. These fees are assessed pursuant to K.C.C. 2.99.030.
36	SECTION 4. Ordinance 6254, Section 6, as amended, and K.C.C. 14.30.060 are
37	each hereby amended as follows:
38	Fee. A. Effective January 1, ((1999)) 2002, a ((seventy-five)) eighty-five-dollar
39	application fee to recover the cost of processing the application as determined by the
40	property services division shall be paid thereto upon filing of the application. The fee is

41	nonrefundable. However, the property services division manager shall have the authority
42	to waive the fees for permits when waiver of the fees is in the best interest of the public
43	health, safety and welfare.
44	B. The property services division shall have the authority to charge an annual fee
45	for uses of county property where appropriate, considering the duration of the proposed
46	use.
47	C. The property services division shall have the authority to require applicants to
48	reimburse King County for all expenses to be incurred by King County as a result of
49	issuance of a special use permit. The payment shall be made at the time of permit
50	issuance.
51	SECTION 5. A. Section 6 of this ordinance proposes changes in the fees
52	currently charged for right-of-way construction permits.
53	B. These fees are assessed pursuant to K.C.C. 2.99.030.
54	SECTION 6. Ordinance 1711, Section 4, as amended, and K.C.C. 14.44.040 are
55	each hereby amended as follows:
56	Construction permit - application - fees. Effective January 1, ((1999)) 2002,
57	each application requires a fee payable to the property services division for the
58	administrative costs and expenses of processing the application.

87	SECTION 7. A. Section 8 of this ordinance proposes changes in the fees
88	currently charged for permits for public and private utilities using real property owned by
89	King County.
90	B. These fees are assessed pursuant to K.C.C. 2.99.030.
91	SECTION 8. Ordinance 4099, Section 8, as amended, and K.C.C. 14.46.080 are
92	each hereby amended as follows:
93	Permit –application and inspection fee. A. Effective January 1, ((1999)) 2002,
94	each application requires a ((seventy-five)) one hundred twenty-five-dollar fee payable to
95	the property services division for the administrative costs and expenses of processing the
96	application.
97	B. In addition, the permittee is required to pay an inspection fee to the
98	department responsible for the management of the property to be affected based on the
99	time spent on the job by inspectors during or after construction.
100	NEW SECTION. SECTION 9. There is hereby added to K.C.C. chapter 14.44 a
101	new section to read as follows:
102	Productivity and customer service report. Concurrent with the annual
103	submittal of the executive proposed budget, on or about October 1 of each year, a report
104	shall be provided to the county council by the property services division or its successor
105	detailing performance measurements for each function within the permit and franchises
106	section or its successor. The performance measurements shall include historical reporting
107	for the current year-to-date and the preceding three years. The data reported is to include
108	but not be limited to: the number of permits and other transactions processed and the

number of employees for each period; the average, longest and shortest periods of time

for permits processed by the division for each year; the criteria used to determine the value of easements and of annual fees for use of county property, demonstrating utilization of commonly accepted principles of real estate appraisal; and the appraisal reports and fee calculation formulas for easements and annual fees for uses for all fees assessed in excess of one thousand dollars.

SECTION 10. This ordinance takes effect January 1, 2002.
