1	AN ORDINANCE designating the official name of the
2	administration/pool house at Cottage Lake park.

5	STATEMENTS OF FACT:
6	1. Louise Miller has been a resident of King County, Washington, since
7	1966. For over thirty-five years, she has lived in the unincorporated area
8	of northeast King County near Cottage Lake park.
9	2. In the years between 1966 and 1982, she shared her passion and talent
10	for music as a music teacher and found her political wings through her
11	election as commissioner to the Woodinville water district.
12	3. In 1982, she won election to the Washington state legislature
13	representing the 45th district. She served six terms from 1983 to 1994 and
14	was instrumental in the passage of legislation supporting cultural and
15	recreation programs in King County.

16	4. In 1993, she was elected to the metropolitan King County council,
17	representing district 3, and brought her passion for the arts and recreation
18	to her new role as a regional leader. In eight years on the council, she has
19	created a legacy of preserving farmlands, protecting waterways,
20	conserving open space and developing parks and renovating ball fields.
21	Through bipartisan leadership and community involvement, she furthered
22	previous initiatives and launched her own successes.
23	5. Cottage Lake park, formerly a private resort, was acquired by the
24	county in 1989. In partnership with King County agencies and the
25	community, Louise Miller helped shape the vision for the park to protect
26	its natural features and provide recreational amenities for the community.
27	6. In 1995, the outdoor pool at Cottage Lake park was renovated and
28	reopened to the public after a six-year closure. On May 28, 1999, the first
29	phase of the master plan was dedicated and officially transformed the park
30	into a regional destination of the King County park system.
31	BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:
32	SECTION 1. In recognition of Louise Miller, who has served the King County
33	community for over thirty-five years, and in honor of her legacy to parks, recreation and

open space in King County, the administration/pool house at Cottage Lake park is now named the Louise Miller Pavilion.
