1 AN ORDINANCE relating to road names, changing the  
2 names of 76th Avenue Northeast, Northeast 112th Street,  
3 and 73rd Avenue Northeast to Champagne Point Road  
4 Northeast, changing the name of 75th Avenue Northeast to  
5 Champagne Point Lane Northeast and changing the name  
6 of a portion of Northeast 112th Street to Northeast  
7 Champagne Point Place.

10 BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

11 SECTION 1. A. The roadway presently known as 76th Avenue Northeast,  
12 Northeast 112th Street, and 73rd Avenue Northeast (also known as Rainer Vista in  
13 accordance with the plan of Juanita Point Division 2) described as follows: beginning at  
14 the southerly margin of Holmes Point Road Northeast and the northeast corner of Lot 46  
15 of Juanita Point Division 2, thence southerly to the southeast corner of Lot 50 of Juanita  
16 Point Division 2, thence southwesterly to the southeast corner of Lot 37 of Juanita Point  
17 Division 2, thence northwesterly to the northwest corner of Lot 1, King County Short Plat

18 S90S0384, thence continuing northwesterly around a hairpin curve, west of Juanita Point  
19 Division 4 and thence continuing around the hairpin curve southeasterly, east of Tract A,  
20 Juanita Point Division 2, thence continuing southeasterly to the northeast corner of Lot 1  
21 of Juanita Point Division 2, is hereby redesignated as Champagne Point Road Northeast  
22 as shown in the map on Attachment A to this ordinance.

23 B. The roadway presently known as 75th Avenue Northeast which is east of a  
24 line described as beginning at the southeast corner of Lot 37 of Juanita Point Division 2  
25 and northerly to the northeast corner of Lot 8 of Juanita Point Division 4, is hereby  
26 redesignated as Champagne Point Lane Northeast as shown in the map on Attachment A  
27 to this ordinance.

28 C. The portion of roadway presently known as NE 112th Street which is north of  
29 a line described as beginning at the northwest corner of Lot 16 of Aviavista, thence  
30 easterly to a point approximately 75 feet east of the northwest corner of Lot 11 of  
31 Aviavista, is hereby redesignated as Northeast Champagne Point Place as shown in the  
32 map on Attachment A to this ordinance.

33 SECTION 2. The twenty-day notice requirement for affected property owners in  
34 K.C.C. 16.08.020 shall be met.

35 SECTION 3. The director of the department of transportation shall accomplish  
36 any necessary sign changes within sixty days of the effective date of this ordinance.

37 SECTION 4. The director of the department of development and environmental  
38 services shall accomplish any necessary address change notifications within seventy days  
39 of the effective date of this ordinance.


40            SECTION 5. Any necessary address changes shall be effective ninety days  
41 following the effective date of this ordinance.


Ordinance 14427 was introduced on 6/24/2002 and passed by the Metropolitan King


