1                   AN ORDINANCE approving the City of Auburn  
2                   Comprehensive Sewer Plan.

5                   PREAMBLE:

6                   K.C.C. chapter 13.24 requires approval of comprehensive plans for sewer utilities  
7 as a prerequisite for granting right-of-way franchises and approval of right-of-way  
8 construction permits.

9                   The City of Auburn Comprehensive Sewer Plan (plan) discusses sewer service to  
10 existing and future populations within the city's twenty-seven-square-mile service area.  
11 The service area includes most of the city of Auburn, a small area in the city of Pacific,  
12 the Muckleshoot reservation, and parts of urban unincorporated King and Pierce counties.  
13 Approximately fifty-nine thousand residents are currently served by the city. At buildout,  
14 the population projected to be served by the city could be nearly one hundred forty-two  
15 thousand.

16                   All of the city's wastewater flows are treated by King County. The average peak  
17 flow currently treated by the county is approximately thirty-five million gallons per day.



this ordinance, is hereby approved without conditions.




