8 BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

9 SECTION 1. There is hereby approved and adopted a supplemental appropriation
10 of \$8,700,000 from the open space non-bond fund sub-fund for the purchase of either a
11 conservation easement or a fee simple interest, or both, for the Treemont conservation
12 acquisition project.

13 SECTION 2. Ordinance 14517, Section 118, as amended, is hereby amended by
14 adding thereto and inserting therein the following:




